Ruling # 17039C The Pennsylvania State Horse Racing Commission (Commission) licenses of Michael J. Sinclair are hereby temporarily suspended pending the Commission's investigatory review of a license suspension action taken by the New York State Gaming Commission (Notice Number: MO 68-2017) for a June 10, 2017, incident at Tioga Downs, NY. On June 28, 2017, Mr. Sinclair declined to provide a Commission investigator a statement regarding the alleged incident until such time as the NY Gaming Commission issued a ruling. Additionally, on June 27, 2017, the USTA took a Membership Action to indefinitely suspend the membership of Mr. Sinclair due to the nature of the Tioga Downs incident. The Commission's regulation 58 Pa. Code §183.253 requires that a trainer must be licensed by the USTA in order to be qualified for licensure in Pennsylvania. Therefore, the temporary suspension will remain in place until such time as Mr. Sinclair's membership in the USTA is reinstated, and the Commission.

During the time of the suspension, all horses owned &/or trained by Mr. Temming shall also be suspended unless transferred to an owner/trainer in good standing. All owner/trainer transfers for Mr. Temming must be approved by the Board of Judges at Harrah's Philadelphia and/or The PSHRC.
