

Northfield Park - 2020 Conditioned Mini Series

No Pre-Nomination Necessary - Just Enter On The Scheduled Date Of The Draw



\$50 Entry Fee for N/W of \$600 Per Start Series
\$100 Entry Fee for N/W of \$1,000 Per Start Series
\$200 Entry Fee for N/W of \$2,000 Per Start Series

(payable night of first start - *entry fee still owed if horse scratches*)

(Eligibility for all series based on average earnings per start in 2019 at time of draw for Leg 1 of Series -- must have at least 6 starts in 2019. Starts made in 2020 will not affect a horse's eligibility.)

The top nine series money earners (no more than two per owner or trainer) who enter will earn spots in the final. The next nine series money earners earn spots in the Consolation (no more than two per owner or trainer). Horses do not have to compete in both preliminary legs to make the Final or Consolation. A second Consolation will be drawn if enough entries are received at discretion of Race Secretary. No horses can race in the Consolation that are eligible to race in the Final. If fewer than 8 horses are in the Consolation, it may be canceled at the discretion of the Director of Racing.

All Series conducted under the rules and regulations of the Ohio State Racing Commission, the United States Trotting Association and Northfield Park. Post positions in all legs drawn by lot. At the time of declaration, with the exception of championship legs or consolations, a horse must meet current qualifying standards at Northfield Park (official track variances allowed). Declarations close in accordance with the current draw schedule at Northfield Park. Starting fee must be paid before horse races. Northfield requires six separate betting interests in any event or it may be canceled. In the event more than eleven enter any preliminary leg, the race will be split into divisions (maximum of ten horses per race if two or more divisions, at discretion of Director of Racing). Northfield reserves the right to reject any entry and return fee, declare off the event if sufficient nominations are not received, and place any horse entered incorrectly into its proper class (all at discretion of Director of Racing). Stall space for all nominees may be revoked at any time. Series Eligibility is based on average earnings per start in 2019 (must have at least 6 starts – starts made in 2020 will not affect horse's eligibility) at time of draw for opening leg of series. Ties for spots in final and consolation will be drawn by lot.
