An analysis of the test sample obtained from FANTASY CRUISER following its fourth-place finish in the sixth race at the Indiana State Fair Consolation Races (Indianapolis) on August 12, 2021, revealed the presence of Dexamethasone and Phenylbutazone in excess of the allowable limits. Trainer Scott Linville chose to waive his right to send a split sample. Therefore, the purse money won by FANTASY CRUISER is hereby ordered forfeited and redistributed among the horses according to their order of finish. Furthermore, trainer Linville is hereby assessed a fine of \$1,000.00.

**POSITIVE TEST- POST RACE** 

PA Code Title 7-203.22, 401.2 A(1).401.41, 205.33, 205.501 (14). Sample #383475 was found to contain Dexamethasone, a Class 4 drug at a level of 2772.5 pg/mL. Sample was provided by #8 Vector, who finished 1st on 1/27/2022 at the Meadows, and was trained by Mr. Porfilio. Mr. Porfilio waived his right to request a split sample. Thus, #8 Vector is disqualified and placed seventh, the purse (\$3950) is ordered to be returned and redistributed, and Mr. Porfilio, trainer of record, is fined \$1000. The fine and purse must be paid within 10 days of this ruling. Mr. Porfilio has 10 days to appeal this decision to the PASHRC, Bureau of Standardbred Racing.

## LOW OR EXCESS LEVEL OF AUTHORIZED MEDICATION

Miami Valley, Trainer Luis Ramirez is hereby issued a warning for violation of Ohio State Racing Commission Rule 3769-18-01 (B)(1). Blood Sample #901036 taken from the horse ATLANTIC STAR and tested by the Analytical Toxicology Laboratory at the Ohio Department of Agriculture on February 16, 2022 showed the presence of Omeprazole Sulfide at a concentration of 13 +/- 2 nanograms per milliliter of plasma, which exceeds the O.S.R.C. regulatory threshold of 10 nanograms per milliliter of plasma.

Due to an excessive amount of penalties for the same offense, Mr. Johnston's penalties for this or any other whipping violation will be increased up to \$500 and/or 5 days. Mr. Johnston has 10 days to appeal this decision to the Pennsylvania SHRC, Bureau of Standardbred Racing.
