#### **POSITIVE TEST- POST RACE**

810 KAR 8:010. Sec. 1(6)(a)--810 KAR 8:030. Sec. 4(3)(a)(2)-- On 07/16/2019, Industrial Laboratories reported to the Kentucky Horse Racing Commission that blood sample E295096 collected on July 2, 2019 at the Marion County Fair at Lebanon, Kentucky revealed Flunixin levels far exceeding those permitted by the KHRC. Horse: "Serrano Volo" winner of the 3rd. race on July 2nd, 2019. Trainer: Harley Emerson. Therefore, Harley Emerson is hereby assessed a civil penalty of \$1500.00 and suspended 10 days, August 19, 2019 through and including August 28, 2019. The purse money won or \$2500.00 is hereby ordered forfeited, returned and redistributed in the following manner. "Serrano Volo" finished 1st. placed unplaced---"Susies Sister" finished 2nd. placed 1st.---"Shawnee Lady" finished 3rd. placed 2nd.---"Likenobodyelse AS" finished 4th. placed 3rd.---"Whatayankee" finished 5th. placed 4th.---"I`m A Country Girl" finished 6th. placed 5th.

***Status as of 5/12/2020 - Subsequent Ruling - Ruling J2019--014 is hereby amended to run concurrently (10-day suspension beginning 05/11/2020) with ruling J2019--018 which specifies a 30-day suspension which will also began on 05/11/2020. The fines imposed and the purse monies forfeited, returned and redistributed remains unchanged.***
