Anthony Alagna was the programmed trainer of the horse #8 ODD`S ON ST LUCIE when it competed in the 9th race on Friday, February 28, 2020. ODD`S ON ST LUCIE finished 2nd in the 9th race and as result, submitted a post-race urine sample for analysis. The urine sample collected identified the presence of the prohibited substance Gabapentin. Mr. Alagna per N.J.A.C 13:71-23.4(d) requested a split sample of the post-race urine sample collected be sent to the Texas A & M Medical Diagnostic Laboratory. Gabapentin was detected in the sample LC-MS/MS at a concentration of 9.3+ 2.0 nanograms per milliliter. The presence of Gabapentin in the horse #8 ODD`S ON ST LUCIE is in direct violation of the New Jersey Racing Commission rule N.J.A.C.13:71-23.1. Consistent with N.J.A.C.13:71-23.7, the horse #8 ODD`S ON ST LUCIE is hereby disqualified from sharing in the purse from the 9th race on Friday, February 28, 2020. The purse is hereby ordered to be redistributed among the remaining finishers.
