### POSITIVE TEST- POST RACE

As a result of the hearing on May 19, 2022, the Board of Judges has determined that: NJRC licensee, Ken Tisa was the programmed trainer of the horse "Western Bayama" when it finished 1st in the 12th race at Freehold Raceway on Saturday, February 19, 2022. The blood sample collected from the horse identified the presence of the prohibited substance Gabapentin. As a result of the positive post-race blood analysis, Mr. Tisa is in violation of NJRC rules and is suspended for a period of 45 days, Friday, July 1, 2022 through and including Sunday, August 14, 2022 and fined the sum of \$1,000.00 dollars. Payment of the fine associated with this ruling must be received by the NJRC on or before August 14, 2022. Consistent with N.J.A.C. 13:71-23.7, the horse "Western Bayama" is hereby disqualified from sharing in the purse from the 12th race on Saturday, February 19, 2022. The purse is hereby ordered to be redistributed among the remaining finishers.

***Status as of 5/31/2022 - Stay - The New Jersey Racing Commission is in receipt of a notice of appeal and a request for a stay from Kenneth Santo Tisa in connection with the 45-day suspension, \$1,000 fine, disqualification of the horse "WESTERN BAYAMA", loss of purse and 2 Multiple Medication Violation (MMV) points issued by the Board of Judges at Freehold Raceway for violation of N.J.A.C. 13:71-23.1, N.J.A.C. 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13:71-7.29(a)13 in connection with the post-race positive result revealing the presence of Gabapentin in the horse "WESTERN BAYAMA" following the 12th race on February 19, 2022. ### CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

An administrative hearing was conducted before the Board of Judges at the Meadowlands Racetrack on May 4, 2022 with NJRC licensee, Mark Toth. As a result, the Board of Judges has determined that: On April 1, 2022, owner Mark Toth did willingly and intentionally throw an object onto the racetrack at the Meadowlands as the field of horses was approaching the finish line presenting a potentially dangerous situation for the horses and drivers; Mr. Toth did act in a manner detrimental to the sport of harness racing and to the integrity of the race itself as well as jeopardizing the health and safety of the horses and drivers competing

in the race; Mr. Toth`s actions are in violation of NJRC rules. As a result, Mr. Toth is hereby issued a full suspension of his NJRC license for a period of 180 days, July 5, 2022 through December 31, 2022 inclusive and is also fined the sum of \$5,000.00 dollars.
