### POSITIVE TEST- POST RACE

OSRC 3769-18-01-B(1,10,13,15,16), 3769 18-02, 3769 17-43. Sample # 905795 was tested by the Ohio Dept. of Agriculture ATL and was found to contain Triamcinolone Acetonide, a class 4 drug, at a concentration of 141 picograms per milliliter of plasma. That concentration exceeds the the Regulatory threshold of 100 picograms per milliliter of plasma adopted by the OSRC. Sample # 905795 was collected from #7 Black Magic, who finished 1st in race 13 on 7/4/22 at Scioto Downs and was trained by Steve Cross. Thus, #7 is disqualified and placed 8th, the purse (\$75,000) is to be redistributed, and Mr. Cross is fined \$1000. The fine must be paid within 10 days of this ruling. Mr. Cross has 48 hours to appeal this decision to the OSRC.

### POSITIVE TEST- POST RACE

Urine sample #895032 collected at Northfield Park on 6/13/22 from the horse Pitt Panda was found to contain 3-Methoxytyramine (3-MT) at a concentration of 9.5+-1.6 micrograms per milliliter of urine. This exceeds the Regulatory Threshold of 4.0 micrograms per milliliter adopted by the OSRC. All purse money must be returned for redistribution (\$4,400.00). This ruling is referred to the commission for further consideration. O.S.R.C.-3769-18-01(B)(10),(13)&(15) 18-02 18-99 If the fine is not paid to the judges by 8/24/22 you shall be suspended and your license may be revoked by the commission. If the purse money is not

Horses owned wholly or in part by the owner shall also be suspended and are not transferable until the purse money has been returned. **POSITIVE TEST- POST RACE**

OSRC-3769-18-01-B(1,10,13,15,16), 3769-18-02, 3769-17-43. Sample #905815 was tested by the Ohio Dept. of Agriculture ATL and was found to contain 3-Methoxytyramine (3-MT), A CLASS 2 drug, at a concentration level of 6.0 micrograms per milliliter of urine. This concentration exceeds the Regulatory Threshold of 4.0 micrograms per milliliter of urine, adopted by the OSRC FOR 3-MT. Sample #905815 was collected from #4 Pitt Panda, who finished 1st in race 14 on 7/6/22 at Scioto Downs and was trained by Ray Farmer. Thus, #4 is disqualified and placed 9th, the purse (\$5500) is ordered returned and redistributed, and Mr. Farmer is fined \$1000, given a one year full suspension (8/15/2023-8/13/2024) a second offense, and referred to the OSRC for further recommendations. During his suspension, Mr. Farmer is denied the use and privileges of all grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Farmer may only be transferred through the judges office at Scioto Downs or by the O
