### POSITIVE TEST- POST RACE

Trainer Kevin Altig, for being the trainer of record on sample #E536233 taken from ALWAYS A SHARK in the 5th race on July 10th, 2022 at Ocean Downs, was found to contain the drug Dexamethasone at a concentration of 29.3 pg/ml. The ARCI threshold for this therapeutic drug is 5 pg/ml. This was identified by Maryland Racing Commission laboratory Industrial Laboratories. At Altig's request, a split sample was analyzed at RMTCC-approved Texas A&M Veterinary Medical Diagnostic Laboratories, which did confirm the presence of Dexamethasone. This is Altig's third positive test in a two year span. As a result, Altig is fined \$500.00, and must return all purse monies. Additionally, he will be issued a 120 day full suspension from September 25th, 2022 through January 22nd, 2023. During this suspension, he and all horses trained and/or owned by him are barred from the grounds, under the jurisdiction of the Maryland Racing Commission. ALWAYS A SHARK finished 1st and was placed last, and also will be

### POSITIVE TEST- POST RACE

OSRC 3769-18-01-B 91,10,13,15,16), 18-02, 17-43. Urine sample #906124 was tested by the Ohio Dept. of Agriculture ATL and found to contain 3-METHOXYTYRAMINE (3-MY), a Class 2 drug, at a concentration level of 5.5 mcg/ml of urine. This exceeds the Regulatory Threshold of 4.0 mcg./ml, adopted by the OSRC for 3-MT. Sample #906124 was collected from #6 Ron's EOM, WHO FINISHED 1ST in race 15 on 7/30/22 at Scioto Downs and was

trained by Mr. Barker. Thus, #6 is disqualified and placed 8th, the purse (\$9,000) is ordered returned and redistributed, Mr. Barker is fined \$1000, given a full one year suspension (09/06/2022-09/05/2023) and referred to the OSRC for any further recommendations. During his suspension, Mr. Barker is denied the use and privileges of all grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Barker may only be transferred by the judges at Scioto Downs or OSRC. The fine and purse must be returned within 10 days of this ruling. Mr. Barker has 48 hours to ap

**POSITIVE TEST- POST RACE**

OSRC-3769-18-01-B(1,10,13,15,16), 18-02, 17-43. Blood sample #906119 was tested by the Ohio Dept. of Agr. ATL and was found to contain Flumethasone, a Class 4 drug. Sample #906119 was collected from #2 Beach House, who finished 1st in race 10 on 7/30/22 at Scioto Downs and was trained by Ms. Brewer. Thus, #2 is disqualified and placed 10th, the purse (\$7500) is ordered returned and redistributed, Ms. Brewer is fined \$1000, and given a full suspension (9/11/22-9/25/22). This is Ms. Brewer`s 2nd offense of a Class 4 drug within 365 days. Should Ms. Brewer not appeal this decision, her full suspension will be (9/11/22-9-17/22). During her suspension, Ms. Brewer is denied the use and privileges of all the grounds sanctioned by the OSRC. All horses owned and/or trained by Ms. Brewer may only be transferred through the Judges office at Scioto Downs or by the OSRC. The fine and purse must be paid within 10 days of this ruling. Ms. Brewer has 48 hours to appeal this decision to the OSRC.

This exceeds the Regulatory Threshold of 5 picograms per milliliter adopted by the OSRC. All purse money must be returned for redistribution (\$2,133.00). On May 25, 2022, Mr. Pruitt orally administered a substance to DR. BRAVESTONE, a horse scheduled to race in race 8 later that day. Additionally, on May 30, 2022, Mr. Pruitt orally administered a substance to LADY ANGEL, a horse scheduled to race in race 4 later that day. Furthermore, on June 1, 2022, Mr. Pruitt again orally administered a substance to DR. BRAVESTONE, a horse scheduled to race in race 8 later that day. DR. BRAVESTONE was ultimately scratched on June 1, 2022, when that administration was discovered. Because of Mr. Pruitt`s admission of guilt and his clean record, his penalty has been mitigated to a forty-five (45) day suspension.
