### **POSITIVE TEST- POST RACE**

Blood sample #904460 collected at the Hartford Independent Fair on 8/12/22 from the horse Vondell Kemp was found to contain betamethasone at a concentration of 34+-2 picograms per milliliter of plasma. This exceeds the Regulatory Threshold of 10 picograms per milliliter adopted by the OSRC. All purse money must be returned for redistribution (\$2,019.00). Mr. Beaver is hereby fined \$1000 and suspended 15 days. The penalty will be reduced to a \$1000 fine if not appealed. O.S.R.C.-3769-18-01(B)(10)&(13) 18-02 18-99 If the fine is not paid to the judges by 9/24/22 you shall be suspended. If the purse money is not returned by 9/24/22 the owner shall stand suspended until all purse money is returned to the permit holder. ### **POSITIVE TEST- POST RACE**

The horse "Anchors Away" winner of the 2nd race on July 30, 2022 at Tioga Downs had a positive finding of METHOCARBAMOL at a higher level than the allowable threshold of 1 Ng/ml in the post-race analysis. Michael Deters, as trainer of record of the horse, is fined \$1,000 and suspended for seven days. Having appeared before a representative of the NYSGC and having waived the right to formal hearing and appeal, the suspension is hereby reduced to 3 days and the fine is reduced to \$500. "Anchors Away" is disqualified from his first place finish. All purse monies paid must be returned and redistributed. The horse "Anchors Away" was required and did submit a negative sample for the above mentioned substance and was allowed to race in the State of New York. During the term of

An analysis of the test sample obtained from PRINCE HENRY following its first-place finish in the fourth race at the Clinton County Fair in Frankfort, IN on 7/4/22 revealed the presence of Triamcinolone acetonide exceeding the level as prescribed by the Indiana Horse Racing Commission. Leander Schwartz, trainer of PRINCE HENRY, was advised of this positive test and of his rights to split sample testing. Mr. Schwartz chose to waive his right to send a split sample. Mr. Schwartz is hereby ordered a fine in the amount of \$1,000,

which has been paid. The purse money won by PRINCE HENRY is hereby ordered forfeited and redistributed among the horses according to their order of finish.

Mr. York waived his right to request a split sample.
