Following this race, INXS was required to submit blood and urine samples for analysis. A report from Industrial Laboratories identified the presence of Tranexamic Acid. Ms. Beaulieu has waived her right to split sample testing as well as her right to a hearing before the Board of Judges concerning this matter: The fine associated with this ruling must be received by the New Jersey Racing commission on or before March 1, 2023.

Post race analysis of sample CV3502901 showed the presence of TESTOSTERONE above the level permitted, which was confirmed by split sample. CENALTA CALL GIRL finished 1st, was disqualified and placed 7th. All purse monies must be returned. Having appeared before representative of the NYSGC and waiving her right to a formal hearing and right to appeal, Ms. Beckwith's 30 day suspension and \$1000 fine is reduced to a 15 day suspension and \$500 fine to be served February 1, 2023 through February 15, 2023. During the term of suspension, Ms. Beckwith is deemed a disqualified person and ruled off. No trainer transfers of horses in her care are permitted.

OSRC-3769-18-01-B(1,10,13,15,16), 18-02, 17-43. Blood sample #906119 was tested by the Ohio Dept. of Agr. ATL and was found to contain Flumethasone, a Class 4 drug. Sample #906119 was collected from #2 Beach House, who finished 1st in race 10 on 7/30/22 at Scioto Downs and was trained by Ms. Brewer. Thus, #2 is disqualified and placed 10th, the purse (\$7500) is ordered returned and redistributed, Ms. Brewer is fined \$1000, and given a full suspension (9/11/22-9/25/22). This is Ms. Brewer's 2nd offense of a Class 4 drug within 365 days. Should Ms. Brewer not appeal this decision, her full suspension will be (9/11/22-9-17/22). During her suspension, Ms. Brewer is denied the use and privileges of all the grounds sanctioned by the OSRC. All horses owned and/or trained by Ms. Brewer may only be transferred through the Judges office at Scioto Downs or by the OSRC. The fine and purse must be paid within 10 days of this ruling. Ms. Brewer has 48 hours to appeal this decision to the OSRC.

Status as of 2/5/2023 - Subsequent Ruling - Ms. Brewer withdrew her appeal and will serve her full suspension from 05/01/23-05/15/23. The purse (\$7500) must be returned to Scioto Downs and the \$1000 fine paid to the OSRC, both by February 16, 2023. During her suspension, Ms. Brewer is denied the use and privileges of all the grounds sanctioned by the OSRC. Thus, #4 All Day Sunshine is disqualified and placed tenth, the purse (\$5150) is ordered to be returned and redistributed, and Mr. Corey, trainer of record, is fined \$500 and given a full 15-day suspension. During his suspension, Mr. Corey is denied the use and privileges of all the grounds sanctioned by the PASHRC. All horses owned and/or trained by Mr. Corey may only be transferred through the Judges office at the Meadows. The fine and purse must be paid within 10 days of this ruling. Mr. Corey has 10 days to appeal this decision to the PASHRC, Bureau of Standardbred Racing.

Status as of 2/7/2023 - Subsequent Ruling - RULING #23001C ORDER AND NOW, this 31st day of January 2023, upon consideration of the testimony and exhibits of record, it is hereby ORDERED that Ruling No. 22041M of the Meadows Board of Judges dated March 17, 2022, which imposed upon Appellant Paul R. CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

PA Code Title 7: 205.401(1) 205.456 205.501(14) 205.404 205.401(5) 205.401(9) 205.401(10) Mr. Peck drove #2, STICK WITH ME, in the 13th race on November 10, 2022 at Harrah's Philadelphia. Just after the 3/8's and continuing to after the 1/2, Mr. Peck drove STICK WITH ME from a 2-wide position to a position on the inside without proper clearance, causing interference to and forcing #6, DOYLE HANOVER, off the track. Mr. Peck made no attempt to steer STICK WITH ME to avoid the interference. The judges' consideration that the interference might have been intentional was confirmed while speaking to Mr. Peck on the phone during the post-race inquiry. Mr. Peck's actions were unreasonable, unprofessional, dangerous, malicious, and injurious to the sport. STICK WITH ME finished 2nd and was placed 7th.

Status as of 2/8/2023 - Subsequent Ruling - RULING#23002C On December 7, 2022, licensed driver Gregory B. Peck ("Appellant") filed an appeal of Ruling No. 22105CD issued by the Harrah's Philadelphia Board of Judges ("Judges") after a full merits hearing. In that appeal, Appellant also sought a stay of Ruling No. 22105CD. The appeal of the Judges' Ruling No. 22105CD was granted by Standardbred Director, Anthony Salerno (Director Salerno) on December 9, 2022, via Ruling No. 22050C. However, in accordance with 7 Pa. Code § 175.6 and the applicable standards set forth in Pennsylvania Public Utility Commission v. Process Gas Consumers Group, 467 A.2d 805 (Pa. 1983) for the issuance of a stay, Appellant's request for a stay was denied (See, Ruling No. 22050C). Appellant did not seek reconsideration of Ruling No. 22105C by the Commission or seek a timely appeal of Ruling No. 22105C in the Commonwealth Court. On January 9, 2023, Appellant through his counsel, submitted a Petition for Stay of Summary Suspension seeking a purported "stay of the summary suspension imposed by Commission Ruling Nos. 22096CD, 22105CD and 22050C" along with an attached affidavit. In accordance with §179.7 (e)(1), Director of Thoroughbred Horse Racing, Thomas Chuckas, has reviewed the procedural issues of the underlying matter and Appellant's January 9, 2023, submission and concludes the following: To the extent Appellant is seeking to appeal Judges' Ruling 22096CD, it is hereby DENIED as improper and untimely pursuant to the Commission's regulations. A retroactive request for a stay in that underlying matter is untimely and

improvidently filed. Accordingly, this matter has been waived and is final and unappealable. (§179.7(b)) To the extent Appellant is seeking to appeal Judges Ruling 22105CD, the underlying appeal was previously granted by Commission Ruling 22050C and a hearing before the full Commission will be scheduled. Ruling No. 22050C issued by Director Salerno also previously denied Appellant's first request for a stay for

Said suspension shall be served on ten (10) consecutive New Jersey Racing Days and shall be served on March 10, 2023, March 11, 2023, March 17, 2023, March 18, 2023, March 24, 2023, March 25, 2023, March 31, 2023, April 1, 2023, April 7, 2023 and April 8, 2023. This is Mr. Stillwell's 2nd violation of N.J.A.C. 13:71-20.15. The fine associated with this ruling must be received by the New Jersey Racing Commission on or before April 8, 2023.
