POSITIVE TEST - ILLEGAL SUBSTANCE TEST

DHRC Licensee Justin King (DHRC #7908) is summarily suspended (Effective 2/22/2023) pending a Judge`s hearing. Mr. King will remain suspended until such a hearing is conducted (See DHRC rule: 10.2.3.1).

POSITIVE TEST - ILLEGAL SUBSTANCE TEST

DHRC Licensee Justin King, having had a Judges hearing on 2/27/2023, is now under a 30 day Full suspension (2/22/2023 through and including 3/23/2023) for failing a human drug test. Mr. King tested positive for Benzoyllecgonine/Cocaine (See DHRC rule: 5.1.8.5.2). Following his completed suspension, Mr. King, in accordance with DHRC rules: 5.1.8.5.5 and 5.1.8.5.6, will be subject to enhanced testing at his expense. The transfer of related ownership and/or training responsibilities, during this suspension, must be approved by the Presiding Judge. Mr. King is responsible for the cost of the failed test (\$32.00).

POSITIVE TEST- POST RACE

Trainer Teresa Willabus, for being the trainer of record on sample #E505987 taken from TEQUILA N ROSES in the 9th race on February 7th, 2023 at Rosecroft Raceway, was found to contain the drug Acepromazine at a concentration of 25.6 ng/ml. The ARCI threshold for this therapeutic drug is 10 ng/ml. As a result, Willabus is fined \$500.00, and must return all purse monies. Additionally, Willabus will be issued a 15-day full suspension from March 1st, 2023 through March 15th, 2023. During this suspension, she and all horses trained or owned by her are barred from the grounds, under the jurisdiction of the Maryland Racing Commission. TEQUILA N ROSES finished 1st and was placed 9th. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of ruling. COMAR: 09.10.03.04.B. 2 Multiple Medication Violation (MMV) points assessed.

Mr. Derue while driving #4 CHAPERIDGE in the 9th Race at Saratoga Harness on February 26, 2023, was in violation of the whipping rule in the stretch. This is Mr. Derue`s

3rd whipping violation within 365 days. Mr. Derue is hereby fined \$500 and issued a 3 day driving suspension to be served March 6, 2023 through and including March 8, 2023. Further violations of this nature will result in greater penalties.

EXCESSIVE OR INDISCRIMINATE USE OF WHIP

Driver Roger Goldstein is hereby issued a driving suspension for a period of five (5) days and is also fined the sum of five hundred (\$500.00) dollars. Said suspension shall be served on five (5) consecutive New Jersey Racing Days and shall be served on February 18, 2023, February 24, 2023, February 25, 2023, March 3, 2023 and March 4, 2023. While driving #7 STICK WITH CRAMER in the 5th race at the Meadowlands Racetrack on February 17, 2023, Mr. Goldstein did violate N.J.A.C. 13:71-20.15 which states: Whipping shall be restricted to wrist action only and the whipping arm shall not be raised above the drivers shoulder height. These actions are in direct violation of the New Jersey Racing Commission rule regarding the restrictive use of the whip. The fine associated with this ruling must be received by the New Jersey Racing Commission on or before March 4, 2023. Violation N.J.A.C. 13:71-20.15(c)3,4.
