REDISTRIBUTION

POSITIVE TEST- POST RACE

OSRC 3769-18-02, 3769-18-01-B(1,10,13,15,16), 3769-17-43. Blood sample #902185 was tested by the Ohio Department of Agriculture ATL and was found to contain Dexamethasone, a Class 4 drug, at a concentration of 88 picograms per milliliter of plasma, which exceeds the Regulatory threshold of 5 picograms per millilter adopted by the OSRC. Blood sample #902185 was provided by #6 Head To The Beach, who finished first in race 14 on 2/20/23 at Miami Valley Raceway, and was trained by Mr. Crawford. Mr. Crawford has declined to request a split sample or DNA test. #6 is disqualified and placed 9th, and the purse (\$3000) is ordered returned within 10 days and redistributed. Mr. Crawford is fined \$1000, which is due within 10 days of this ruling. Mr. Crawford has 48 hours to appeal this decision to the OSRC.

MEDICATION PROCEDURE VIOLATION

After a hearing at the Judges' office on October 21, 2022, the Judges have found that IHRC licensed trainer Melanie Wrenn violated 71 IAC 8-1-1.5(a) & (b)(1), 71 IAC 5-3-2(a) & (b), 71 IAC 5-3-3(a)(5), (14), (15) &(31), 71 IAC 5-3-3.1, 71 IAC 8-1-4.1(a) when the horse "Helpoftheseason" in which she is the listed trainer was administered Flunixin on race day, 9/13/22, by Dr. Keith Hollendonner, an IHRC licensed veterinarian, after being presented the horse by Claude Faucher, a groom employed by Wrenn. Dr. Hollendonner was unaware that the horse was racing that day; Wrenn was unaware that the horse was and injected with Flunixin. "Helpoftheseason" was tested post-race on 9/13/22, and the test came back positive for Flunixin. As Wrenn was unaware her horse was being treated on race day and was fully cooperative during the investigation, her penalty has been mitigated to a \$1000 fine and one-hundred eighty (180) days suspension. **Contact IHRC for complete ruling**

Status as of 3/28/2023 - Subsequent Ruling - Pursuant to a Settlement Agreement approved by the Indiana Horse Racing Commission on March 21, 2023, Melanie Wrenn has agreed to a reduced suspension from ninety (90) days to seventy-five (75) days and no probationary period, the suspension having ended on January 28, 2023. Ms. Wrenn has also agreed to several conditions on her 2023 license. The sanctions above not involving a suspension of her license or probation on her license were not a part of the Settlement Agreement and remain as is.
