RULING# 23003C On March 23, 2023, the Pennsylvania State Horse Racing Commission, Bureau of Standardbred Horse Racing ("Commission"), received a license application from Samantha J. Blystone seeking to be licensed as a Groom. In accordance with Section 9323 (g.1) of the Race Horse Industry Reform Act (3 Pa.C.S. § 9323 (g.1)), the Commission hereby DENIES Ms. Bylstone's license application for the following reasons: Applicant is denied due to her conviction of any violation or attempt to violate any law, rule or regulation of horse racing in any jurisdiction. Applicant is denied due to violating a rule, regulation or order of the Commission. Applicant is denied due to her failure to demonstrate by clear and convincing evidence that she is a person of good character, honesty and integrity. Applicant is denied due to being a person whose prior activities, reputation, habits, and associations pose a threat to the public interest or the effective control and regulation of horse racing. Applicant is denied due to being a person whose prior activities, reputation, habits, and associations create or enhance the danger of unsuitable, unfair, or illegal practices, methods and activities in the conduct of horse racing or the carrying on of the business and financial arrangements incidental to the conduct of horse racing. To the extent this denial is based on pending criminal charges against Applicant for her role in an alleged criminal scheme of artifice involving the horse racing industry, the applicant may reapply if and when those charges are resolved.

OSRC 3769-18-01-B(4d,10&13), 3769-18-02, 3769-17-43. Blood sample #911018 was tested by the Ohio Dept. of Agriculture ATL and showed a TCO2 concentration of 39.8 millimoles per liter of serum, which exceeds the regulatory threshold of 37 millimoles per liter adopted by the OSRC. Blood sample #911018 was provided by #3 Bettor Of The West, who finished 1st in race 11 on 2/28/23 at Miami Valley Raceway, and was trained by Mr. Galliers. #3 is disqualified and placed 10th, and the purse (\$7000) is ordered to be returned and redistributed. The fine of \$1000 and purse must be paid within 10 days of this ruling. This is Mr. Galliers 2nd medication violation within the last 365 days. He is given a full 60 days (4-11-23 thru 6-09-23) suspension, or a full 30 days (4-11-23 thru 5-10-23) if not appealed. During his suspension, Mr. Galliers is denied the use and privileges of all grounds sanctioned by the OSRC. All horses owned and/or trained may only be transferred by the judges or the OSRC. Mr. Galliers has 48 hours to appeal this decision to the OSRC.

Frank Multari was the programmed trainer of the horse CC BANK when he raced in the 11th race at the Meadowlands Racetrack on February 25, 2023. Following this race, CC BANK was selected to submit post-race blood and urine samples for analysis. A report from Industrial Laboratories identified the presence of Albuterol. Mr. Multari has waived his right to have a split sample testing performed and has also waived his right to a hearing before the Board of Judges. Due to the aggravating factors that this is Mr. Multari's 2nd Medication Violation within one year, Mr. Multari will be issued a full suspension of his New Jersey Racing Commission license for a period of twenty (20) days and fined the sum of one thousand (\$1,000.00) dollars. Said suspension shall begin on April 3, 2023 and run through April 22, 2023 inclusive. During the period of suspension, Mr. Multari is denied all access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. Consistent with N.J.A.C.13:71-23.7, the horse CC BANK is hereby disqualified from sharing in the purse from the 11th race on February 25, 2023. The payment of the fine associated with this ruling must be received by the New Jersey Commission on or before April 22, 2023. OSRC 3769-18-01-B(1/10,13,15,16),3769-18-02, 3769-17-43. Blood sample #910599 was tested by the Ohio Department of Agriculture ATL and was found to contain Triamcinolone acetonide, a Class 4 drug, at a concentration of 104 picograms per milliliter of plasma, which exceeds the Regulatory threshold of 100 picograms per milliliter that was adopted by the OSRC. Sample #910599 was provided by #4 Hez A Dude A, who finished 1st in race 9 on 1/16/23 at Miami Valley Raceway, and was trained by Mr. Rose. Mr. Rose did request a split sample which was confirmed at 109 picograms per milliliter of plasma. #4 is disqualified and placed 10th, the purse (\$7500) is ordered returned and redistributed, and Mr. Rose is fined \$1000. The fine and purse must be paid within 10 days of this ruling. Mr. Rose has 48 hours to appeal this decision to the OSRC.
