RULING# 23003C On March 23, 2023, the Pennsylvania State Horse Racing Commission,
Bureau of Standardbred Horse Racing ("Commission"), received a license application from
Samantha J. Blystone seeking to be licensed as a Groom. In accordance with Section 9323
(g.1) of the Race Horse Industry Reform Act (3 Pa.C.S. § 9323 (g.1)), the Commission
hereby DENIES Ms. Bylstone's license application for the following reasons: Applicant is
denied due to her conviction of any violation or attempt to violate any law, rule or regulation
of horse racing in any jurisdiction. Applicant is denied due to violating a rule, regulation or
order of the Commission. Applicant is denied due to her failure to demonstrate by clear and
convincing evidence that she is a person of good character, honesty and integrity. Applicant

is denied due to being a person whose prior activities, reputation, habits, and associations pose a threat to the public interest or the effective control and regulation of horse racing. Applicant is denied due to being a person whose prior activities, reputation, habits, and associations create or enhance the danger of unsuitable, unfair, or illegal practices, methods and activities in the conduct of horse racing or the carrying on of the business and financial arrangements incidental to the conduct of horse racing. To the extent this denial is based on pending criminal charges against Applicant for her role in an alleged criminal scheme of artifice involving the horse racing industry, the applicant may reapply if and when those charges are resolved.

Ann Depietro was the programmed trainer of the horse "Shaving Mug" when he raced in the eleventh race at Freehold Raceway on November 28, 2020. Following this race, "Shaving Mug" was required to submit a urine sample for analysis. A report from ALS Group, USA laboratories identified the presence of the drug Dextrorphan. As a result, Ms. Depietro is issued a full suspension of her New Jersey Racing Commission license for a period of fifteen (15) days and fined the sum of five-hundred (\$500.00) dollars. Said suspension shall begin on April 12, 2021 and run through April 26, 2021 inclusive. During the period of suspension, Ms. Depietro is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. Consistent with N.J.A.C. 13:71-23.7, the horse "Shaving Mug" is disqualified from sharing in all purse monies earned on November 28, 2020. MMV points incurred: 2 points Violation of N.J.A.C. 13:71-23.1 (a) (b) Violation of

Status as of 4/13/2023 - Subsequent Ruling - By Ruling No. 21FRE37, dated March 24, 2021, the Board of Judges found trainer Ann DePietro to be in violation of N.J.A.C. 13:71-23.1(a)(b), N.J.A.C. 13:71-23.6(a)(b)(c)(d), and N.J.A.C. 13:71-23.7(a)(b)(c)(d) in connection with a post-race positive test result revealing the presence of Dextrorphan in the horse "SHAVING MUG" after the 11th race at Freehold Raceway on November 28, 2020. The Board of Judges imposed a 15-day suspension, \$500 fine, 2 Multiple Medication Violation points and disqualified the horse from sharing in all purse monies. Ms. DePietro appealed the decision of the Board of Judges and requested a stay of the penalties. By ruling 21TRH7, dated April 9, 2021, a stay was granted and the matter was transmitted to the Office of Administrative Law for a de novo hearing as a contested case. As a result of an agreed upon disposition of the appeal, trainer Ann DePietro is hereby suspended for 20 days and will receive 1 Multiple Medication Violation point. Said suspension will be served from May 12, 2023, through and including May 31, 2023. The horse "SHAVING MUG" is hereby disqualified from sharing in the purse from the 11th race on November 28, 2020. The Horsemen's Bookkeeper is hereby ordered to redistribute the purse monies from the 11th race on November 28, 2020 at Freehold Raceway accordingly. During the period of suspension, Ann DePietro is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. New Jersey Racing Commission ("NJRC") licensee, Greg Peck, was scheduled to appear at a hearing before the Board of Judges at the Meadowlands Racetrack on April 6, 2023 at 1:00 PM. The purpose of this hearing was to accept evidence and testimony relating to the allegations that Mr. Peck failed to cooperate with an ongoing investigation conducted by the NJRC, actions which are in possible violation of N.J.A.C. 13:71-7.29(a)1,13, N.J.A.C. 13:71-23.12, N.J.A.C. 13:71-26.7 and N.J.A.C. 13:71-7.32 (a) 1, 3. Having failed to appear at the April 6, 2023 hearing, the Board of Judges hereby order a full suspension of any and all NJRC licenses issued to Greg Peck, effective immediately as of today, April 7, 2023. As a result, Robinson is fined \$1000.00, and must return all purse monies. Robinson will also be issued a full suspension from April 14th, 2023 through May 13th. 2023. During this suspension, he and all horses trained and/or owned by him are barred from the grounds, under jurisdiction of the Maryland Racing Commission. Additionally, CRUSH HANOVER finished first and is placed eighth, and is placed on the stewards list from April 14th, 2023 through May 13th, 2023 as well. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of ruling.
