### **POSITIVE TEST- POST RACE**

Trainer Archie Buford, for being the trainer of record on sample #E603245 taken from IDEAL BIG GUY in the 7th race on April 2nd, 2023 at Shenandoah Downs, was found to contain the drug Methocarbamol at a concentration of 3.13 +- 0.17 ng/mL. The ARCI threshold for this drug is 1 ng/mL. As a result, Buford is fined \$500.00 and must return all purse monies. Additionally, IDEAL BIG GUY is disqualified, finishing 2nd placed 6th. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of the ruling. 11VAC10-180-60-4. 1/2 Multiple Medication Violation (MMV) points assessed.

**POSITIVE TEST- POST RACE**

By Amended Ruling No. 21MDH80, dated November 12, 2021, trainer Alexandra Goldin was issued a 30-day suspension, \$1,000 fine, disqualification of the horse "CHEYENNE RYAN LEE", loss of purse and 1 Multiple Medication Violation points for violation of N.J.A.C. 13:71-23.1, N.J.A.C. 13:71-23.6, and N.J.A.C. 13:71-23.8 in connection with post-race positive test results revealing the presence of Phenylbutazone and Flunixin in the horse "CHEYENNE RYAN LEE" after the 5th race on September 25, 2020 and after the 8th race on October 31, 2020 at the Meadowlands Racetrack. Ms. Goldin appealed the decision of the Board of Judges and requested a stay of the penalties. By Ruling No. 21TRH33, dated December 1, 2021, a stay was granted and the matter was transmitted to the Office of Administrative Law ("OAL") as a contested case. On February 1, 2023, Administrative Law Judge Joann Candido ("ALJ") issued an initial decision, which affirmed the determination of the Board of Judges regarding the rules violated and the penalties imposed. At its March 22, 2023 meeting, the New Jersey Racing Commission determined to adopt the initial decision. Having adopted the initial decision, the penalties issued in Ruling No. 21MDH80 are reinstated. Alexandra Golden is hereby suspended from May 12, 2023 through and including June 10, 2023. Payment of the fine is due on or before June 10, 2023. The Horsemen's Bookkeeper is hereby ordered to redistribute the purse monies from the 5th race on September 25, 2020 and the 8th race on October 31, 2020 at the Meadowlands Racetrack accordingly. During the period of suspension, Alexandra Golden is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. At the head of the stretch, Mr. Polisenno engaged in conduct that was un-sportsmanlike, detrimental, and injurious to the sport by elbowing a trailing horse, in the head, at least two times. Mr. Polisenno is fined \$250 (fines are due within ten days of ruling) and issued a five day (November 25,26,27,28, & 29, 2022) suspension from driving in overnight events. The ARCI threshold for this drug is 100 pg/mL. As a result, Roberts is fined \$500.00 and must forfeit all purse monies. CENTURY HEFNER is disqualified, finishing 1st and was placed last. All fines are due within 10 days of the ruling, and all purse monies must be returned within 72 hours of this issuance. COMAR: 09.10.03.04B. 1/2 Multiple Medication Violation (MMV) points assessed.

**POSITIVE TEST- POST RACE**

As a result of the administrative hearing conducted on April 6, 2023 the Board of Judges has determined that; NJRC licensee, Tom Shay was the programmed trainer of the horse BAD MEDICINE when it competed in the 4th race at Freehold Raceway on Friday, November 11, 2022; BAD MEDICINE finished 2nd in the race; Following its performance BAD MEDICINE was selected to submit blood and urine samples for analysis; The urine sample collected identified the presence of the prohibited substance Benzoylecgonine; The presence of Benzoylecgonine is in direct violation of NJRC rule N.J.A.C. 13:71-23.1; Mr. Shay per N.J.A.C. 13:71-23.4(d) requested a split sample of the post-race urine sample collected be sent to Texas A&M Veterinary Diagnostic Laboratory. The lab at Texas A&M Diagnostic Laboratory confirmed the presence of Benzoylecgonine in the sample. As a trainer licensed by the NJRC, Mr. Shay; is the absolute insurer of and responsible for the condition of a horse within his care and custody; shall not enter or start a horse that has in its body any drug or substance foreign to the natural horse; has the duty to be familiar with medication rules of the Commission and with any drug or substance foreign the natural horse administered to said horse at his direction or while in his custody and care; As a result of the positive post-race urine analysis, Mr. Shay is in violation of N.J.A.C. 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13.71-23.4(d). Mr. Shay is fined the sum of \$1000.00 which must be received by the NJRC on or before May 15, 2023. Mitigating circumstances were used in the deliberation of this penalty. Consistent with N.J.A.C. 1 BAD MEDICINE is hereby disqualified from sharing in the purse from the 4th race on Friday November 11, 2022. The purse is hereby ordered to be redistributed among the remaining finishers. In

addition to the penalty issued, 4 Multiple Medication Violation (MMV) points as recommended ARCI shall be assigned as a result of this Class B violation.
