POSITIVE TEST- POST RACE

OSRC 3769-18-01-B(1,10,13,15,16), 3769-18-02,3769-17-43. Blood sample #911213 was tested by the Ohio Department of Agriculture ATL and was found to contain Dexamethasone, a Class 4 drug, at a concentration of 17.5 picograms per milliliter of plasma, which exceeds the Regulatory threshold of 5 picograms per milliliter adopted by the OSRC. Blood sample #911213 was provided by #5 Always At My Place, who finished 1st in race 11 on 3/20/23 at Miami Valley Raceway, and was trained by Ms. Perrin. Ms. Perrin has declined a split sample and DNA, and waived her right to a hearing. #5 is disqualified and placed 10th, and the purse (\$6000) is ordered returned within 10 days and redistributed. Ms. Perrin is fined \$1000, which is due within 10 days of this ruling. Ms. Perrin has 48 hours to appeal this decision to the OSRC.

LOW OR EXCESS LEVEL OF AUTHORIZED MEDICATION

71 IAC 5-3-2(a)(1), 5-3-2(a)(2), 8-1-2(b), 8-1-4.1(a)(1) Sample No. E57781 taken from the horse No. 7 MAXDADDY BLUE CHIP following the conclusion of race 1 on 4/7/2023 at Hoosier Park tested positive for phenylbutazone at level of 0.950 mcg/mL +/- 0.047 mcg/mL which exceeds the IHRC threshold level of 0.3 mcg/mL. As trainer of record Rick Plano is in violation of the IHRC trainer responsibility and medication rules. Mr. Plano waived his right to a hearing and accepted the following penalties: 1. \$1000.00 fine which is due within 7 days of this ruling. 2. All purse monies earned (\$924.00) in this race by MAXDADDY BLUE CHIP must be returned and redistributed as follows: No. 7 MAXDADDY BLUE CHIP finished third placed eighth No. 8 STORMY SKIES finished fourth placed third No. 2 MAXIMUS finished fifth placed fourth No. 1 MANNYS TOO SPECIAL finished sixth placed fifth No. 4 ALWAYS A WARRIOR finished seventh placed sixth No. 3 ARRHTHMIC STORM finished eighth placed seventh Mr. Plano is assessed 1/2 Multiple Medication Violation (MMV) point.
