Daniel Renaud was the programmed trainer of the horse "Casual Cool" when he raced in the 10th race at the Meadowlands Racetrack on February 11, 2023. Following this race, "Casual Cool" was required to submit blood samples for analysis. A report from Industrial

Laboratories identified the presence of Phenylbutazone above the allowable limits. As a result, Mr. Renaud is issued a full suspension of his New Jersey Racing Commission license for a period of fifteen (15) days and fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on April 25, 2023 and run through May 9, 2023. During the period of suspension, Mr. Renaud is denied all access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. Mr. Renaud has waived his right to split sample testing as well as his right to a hearing with the Board of Judges. Consistent with N.J.A.C. 13:71-23.7, the horse "Casual Cool" is hereby disqualified from sharing in the purse on February 11, 2023. The fine associated with this ruling must be received by the New Jersey Racing Commission on or before May 9, 2023. While driving DREAMELLA in the 6th race at Freehold Raceway on Friday, December 3, 2021. Mr. Sheridan did violate the New Jersey Whipping Rule regarding the restrictive use of the whip by whipping other than wrist action and raising his whipping arm above his shoulder. Mr. Sheridan also moved his arm in an exaggerated manner. After a hearing with the Board of Judges, Driver Mark Sheridan is hereby issued a driving suspension for a period of five (5) days and is also fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin March 1, 2022 and run through March 5, 2022 inclusive. This ruling vacates and replaces the original ruling 21FRE96. The fine issued herein shall be received by the New Jersey Racing Commission not later than March 5, 2022. Violation of N.J.A.C. Rule 13:71-20.15(c) 3,4 BY ORDER OF THE NEW JERSEY RACING COMMISSION BOARD OF JUDGES

Status as of 5/3/2023 - Subsequent Ruling - By Ruling No. 22FRE18, dated February 4, 2022, the Board of Judges at Freehold Raceway found Mark N. Sheridan in violation of N.J.A.C. 13:71-20.15(c) 3,4 of in connection with the restrictive use of the whip on the horse "DREAMELLA" in the 6th race on December 3, 2021. The Board of Judges imposed a 5-day suspension and \$500 fine. Mr. Sheridan appealed the decision of the Board of Judges and requested a stay of the penalties. By Ruling No. 22TRH16, a stay was granted and the matter was transmitted to the Office of Administrative Law ("OAL") as a contested case. On February 13, 2023, Mr. Sheridan failed to appear at the OAL for the scheduled hearing. As a result, the OAL returned his case file to the NJRC and indicated that if Mr. Sheridan still wanted to have a hearing, he must explain in writing why he did not appear and send the explanation to the NJRC. On March 2, 2023, the NJRC received a letter from Mr. Sheridan stating that a misunderstanding caused his failure to appear. Mr. Sheridan requested that the appeal be retransmitted to the OAL. The Executive Director, having considered the request, hereby orders that the matter be retransmitted to the OAL for a de novo hearing and grants a stay of the penalties pending a final determination by the Racing Commission.
