### POSITIVE TEST- POST RACE

Miss Arrigena was the trainer of record for Tiger Baron in the 8th race at Yonkers Raceway on 4/27/23. Post race analysis of sample showed the presence of Isoflupredone above the level permitted by the Commission. Having appeared before a representative of the NYSGC and having waived her right to a split sample being tested, Miss Arrigena is issued a 15 day full suspension reduced to 7 days and issued a \$500 fine reduced to \$250 without an appeal. During the term of suspension, Miss Arrigena is deemed a disqualified person and ruled off all grounds under the jurisdiction of the NYSGC, and barred from all racing activities. All purse monies earned in the above mentioned race are ordered to be returned and redistributed (purse has been returned). The horse has subsequently submitted to a retest since this positive result and has been cleared.

race analysis on 3/14 and pre race analysis on 3/15 of sample showed the presence of COBALT above the level permitted by the Commission. Having appeared before a representative of the NYSGC and having waived his right to a split sample being tested, Mr. Hudson is issued a 60 day full suspension and issued a \$2,000 fine. During the term of suspension, Mr. Hudson is deemed a disqualified person and ruled off all grounds under the jurisdiction of the NYSGC, and barred from all racing activities. Both horses are hereby disqualified and placed last. All purse monies earned in the above mentioned races are ordered to be returned and redistributed (purse has been returned). The horses have subsequently both submitted clean samples since this positive result. THIS RULING IS CURRENTLY UNDER APPEAL. You have requested a hearing on this matter. Therefore, a stay of the suspension or revocation of your license is hereby granted; however, Commission counsel may request that the Commission terminate the stay in the event that the hearing is not completed within 90 days of this ruling. If the stay is terminated because of unreasonable delay in the completion of the hearing, then your license suspension or revocation would begin and run until the hearing is completed. You are hereby granted a separate stay for the period from when the hearing is completed to when the Commission announces its final agency action (e.g., finding and order).

Following the 6th race, SALVADORES` SUN was selected to submit blood and urine for analysis. The blood sample collected from the horse SALVADORES` SUN on April 7, 2023 identified the presence of the prohibited substance Methocarbamol. Having waived his right to a hearing, Mr. Sciarrino is issued a full suspension of his New Jersey Racing Commission license for a period of fifteen (15) days and fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on May 10, 2023 and run through May 24, 2023 inclusive. During the period of suspension, Mr. Sciarrino is denied access to all grounds under jurisdiction of the New Jersey Racing Commission for any and all purposes. The fine associated with this ruling must be paid on or before May 24, 2023. Consistent with N.J.A.C 13:71-23.7, the horse SALVADORES` SUN is disqualified from sharing in all purse monies earned on April 7, 2023. MMV points incurred 1/2 point. Total Carbon Dioxide was confirmed in the blood at 47.36 mmol/L. The measurement uncertainty of the method is 2.83 mmol/L at the threshold of 37 mmol/L. In addition Industrial Labs reported a Pre Race result of Blood Sample E570996 collected from the horse MEADOWBROOK JENNY in Race 5 on 04/25/2023 at 44.12 mmol/l and did not finish. It was also reported that the Pre Race result of Blood Sample E571000 taken from the horse DARK ECLIPSE N who raced on 04/25/2023 at 45.74 mmol/L in Race 7 and finished 7th. After waiving her right to quarantine the horses and conducting a hearing trainer Lisa Zablielski is hereby suspended from training for 30 days beginning 05/24/2023 through and including 06/22/2023. The horse RACEY RACH N finished 2nd and was disqualified and placed last. The purse money won or \$4,000.00 is hereby ordered forfeited, returned and redistributed. Purse money forfeited must be returned within 10 days of ruling.
