Blood sample #915005 was tested by the Ohio Dept. of Agriculture ATL and was found to contain Flunixin, a Class 4 drug, at a concentration level of 27 nanograms per milliliter of plasma, which exceeds the Regulatory threshold of 20 nanograms per milliliter, adopted by the OSRC for Flunixin. Sample #915005 was collected from #5 Head To The Beach, who finished 1st in race 3 on 4/19/23 at Miami Valley Raceway, and was trained by Mr. Crawford. This is Mr. Crawford's first offense of a NSAID in Ohio, but his second medication violation in the last 365 days. Mr. Crawford did not request a split sample.
