#### POSITIVE TEST- POST RACE

Williams Hernandez was the programmed trainer of the horse "Big Smoove" when he raced in the 2nd race at Freehold Raceway on April 24, 2021. Following this race, "Big Smoove"

was required to submit a blood sample for analysis. A report from Industrial Laboratories identified the presence of Flunixin above the allowable limits. As a result, Mr. Hernandez is issued a full suspension of his NJRC license for a period of 15 days and fined the sum of 500.00 dollars. Said suspension shall begin on June 10, 2022 and run through June 29, 2022, inclusive. During the period of suspension, Mr. Hernandez is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. The fine associated with this ruling must be paid on or before June 29, 2022. Consistent with N.J.A.C. 13:71-23.7, the horse "Big Smoove" is disqualified from sharing in all purse monies earned on April 24, 2021. For full ruling, contact NJRC. Status as of 1/23/2023 - Amendment - Williams Hernandez withdrew his appeal in Williams Hernandez v.
