Following this race, "Lets Foal Around" was required to submit a blood sample for analysis. A report from Industrial laboratories identified the presence of the drug Aminocaproic Acid. As a result, Mr. Bena is hereby fined the sum of one-thousand (\$1,000.00) dollars. The fine associated with this ruling must be paid on or before August 12, 2021. **DENIAL OF LICENSE**

71 IAC 5-1-12 Bobby Brower submitted an application for a 2023 owner/trainer/driver license with the Indiana Horse Racing Commission (IHRC). On March 14, 2023 Executive Director Deena Pitman issued a refusal of this license. Mr. Brower contested this decision in a timely fashion. Per IHRC rules 71 IAC 10 and IC 4-21.5, Mr. Brower was given a hearing. This hearing was conducted by the Indiana Horse Racing Commission judges on Wednesday, May 10, 2023 at Hoosier Park. After hearing testimony from Mr. Brower, his attorneys, and Mr. Brower's witness, the judges determined that the decision to refuse the license was correct and hereby affirm that decision. Additionally, in accordance with 71 IAC 5-1-12, the decision to affirm the refusal of Mr. Brower's license application is treated as a denial of said application.

PA Code Title 7-203.22, 401.2 A(1).401.41, 205.33, 205.501 (14). Sample #376667 was found to contain Triamcinolone acetonide, a Class 4 drug at a level of 130.8 pg/mL. Sample was provided by #1 Fiftyfour K, who finished 1st on 7/30/2021 at the Meadows, and was trained by Mr. Burke. A request for a split sample also contained Triamcinolone acetonide at a level of 156 pg/mL. Thus, #1 Fiftyfour K is disqualified and placed eighth, the purse (\$9030) is ordered to be returned and redistributed, and Mr. Burke, trainer of record, is

fined \$1500 and given a full 15 day suspension. During his suspension, Mr. Burke is denied the use and privileges of all the grounds sanctioned by the PASHRC. All horses owned and/or trainer by Mr. Burke may only be transferred through the Judges office at the Meadows. The fine and purse must be paid within 10 days of this ruling. Mr. Burke has 10 days to appeal this decision to the PASHRC, Bureau of Standardbred Racing.

### **POSITIVE TEST- POST RACE**

Ms. Goldin was the programmed trainer of #10 CHEYENNE RYAN LEE that raced in the 5th race on Friday, September 25, 2020. Following this race CHEYENNE RYAN LEE was required to submit to a post-race blood sample for quantitative analysis. The final forensic analysis from ALS -Truesdail Laboratories, Inc. report identified the presence of Phenylbutazone and Flunixin. This is a violation of N.J.A.C. 13:71-23.8(g) Ms. Goldin was the programmed trainer of CHEYENNE RYAN LEE that raced in the 7th race on Saturday, October 3, 2020. Following this race CHEYENNE RYAN LEE was required to submit to a

post-race blood sample for quantitative analysis. The final forensic analysis from ALS - Truesdail Laboratories, Inc. report identified the presence of Phenylbutazone and Flunixin. Ms. Goldin as per her rights requested a split sample of the post-race blood test on CHEYENNE RYAN LEE be sent to the Industrial Laboratories Company, Wheat Ridge, Corlorado. The sample was received in acceptable/secure condi

**Status as of 6/21/2023 - Subsequent Ruling - By Amended Ruling No. 21MDH80, dated November 12, 2021, trainer Alexandra Goldin was issued a 30-day suspension, \$1,000 fine, disqualification of the horse "CHEYENNE RYAN LEE", loss of purse and 1 Multiple Medication Violation points for violation of N.J.A.C. 13:71-23.1, N.J.A.C. 13:71-23.6, and N.J.A.C. 13:71-23.8 in connection with post-race positive test results revealing the presence of Phenylbutazone and Flunixin in the horse "CHEYENNE RYAN LEE" after the 5th race on September 25, 2020 and after the 8th race on October 31, 2020 at the Meadowlands Racetrack. Ms. Goldin appealed the decision of the Board of Judges and requested a stay of the penalties. **REFUSAL OF AUTHORITIES TO CONDUCT A SEARCH OF BARN AREA OR VEHICLE**

As a result of the administrative hearing conducted on December 21, 2021, the Board of Judges has determined that: On December 9, 2021 NJRC authorized the NJ State Police to conduct a barn inspection of the stabling area of the NJRC licensee Travion Jones at Congress Hill Farm, an off-track stabling facility licensed by and under the jurisdiction of the NJRC; On December 12, 2021, two detectives from the NJ State Police attempted to conduct a barn inspection of the stabling area; During the inspection, Jones was very uncooperative, locked his vehicle and refused to allow the detectives to complete the inspection, became extremely confrontational with the detectives, disturbing the peace and threatening other licensees on the farm. Jones is in violation of of NJAC 13:71-1.7; 13:71-7.29(a)9,13; 13:71-23.12; 13:71-26.5; 13:71-26.7. As such, he is hereby suspended for a period one year and fined the sum of \$5,000. Suspension shall begin March 11, 2022 and continue through March 10, 2023.

At its May 24, 2023 meeting, the New Jersey Racing Commission adopted the initial decision. Having adopted the initial decision, the penalties issued in 22FRE19 are reinstated. Travion Lamar Jones is hereby suspended for a period of one year and fined the sum of \$5,000.00 dollars.
