PA Code Title 7-203.22(a) 203.22(b) 401.2(a)(1) 401.3(a) 401.3(b) Mr. Bush was the trainer of the horse BOUGIELIKENATTY for the 6th race on May 10, 2023 at The Meadows. Blood and urine samples collected (post-race) from BOUGIELIKENATTY were tested and found to contain Levamisole. As the trainer, Mr. Bush is responsible for the positive test. Mr. Bush is fined \$500 (fines are due within ten days of ruling) and issued a fifteen-day full suspension. The fifteen-day full suspension will be held in abeyance; if Mr. Bush has no major medication violations within six months of this ruling, he will not have to serve this suspension. Mitigating factors were considered in the determination of the penalty. BOUGIELIKENATTY finished 1st in this race but has been disqualified. Purse money earned (\$5,450) must be returned within ten days of this ruling. MR. Bush has waived his hearing/appeal rights.

Client ID E607424 sample was sent to Industrial Laboratories for testing. Industrial Laboratories found the presence of Cobalt at the level of 41.1 ppb which is over the allowed level of 25 ppb. Mr. Erickson was offered opportunity to request a split sample and he did deny and sign the Waiver of Hearing. #4 Corona Cobra has been disqualified and placed 7th and the Board of Judges have ordered all purse money, \$3625.00 to be redistributed.

When stopped at the stable gate and asked to show his Indiana Horse Racing Commission license he became argumentative with Hoosier Park security. When the security supervisor intervened, Mr. Hochstetler became agitated and yelled "f\*ck you" before leaving the area to retrieve his badge. Upon returning

to the stable gate with his badge, Mr. Hochstetler asked for the "cigar bastard." For this violation Mr. Hochstetler is fined \$500.00 which is due within seven days of this ruling. Mr. Hochstetler waived is right to a hearing and agreed to the penalty.

Blood samples collected (post-race) from BUCKEYE CASH were tested and found to contain Aminorex. As the trainer, Ms. Kahrig is responsible for the positive test. Ms. Kahrig is fined \$750 (fines are due within ten days of ruling) and issued a fifteen-day full suspension. The fifteen-day full suspension will be held in abeyance; if Ms. Kahrig has no major medication violations within six months of this ruling, she will not have to serve this suspension. Mitigating factors were considered in the determination of the penalty. BUCKEYE CASH finished 1st in this race but has been disqualified. Purse money earned (\$5,450) must be returned within ten days of this ruling. Ms. Kahrig has waived her hearing/appeal rights.

This kind of conduct is detrimental to the best interest of horse racing. Mr. Luther is fined \$1000 and given a 10 day full suspension (07-07-2023 thru 07/16/2023). All horses owned and/or trained by Mr. Luther may only be transferred by the judges or the OSRC during his suspension. During the suspension, Mr. Luther is denied the use and privileges of all the grounds sanctioned by the OSRC. The penalty will be reduced to just a \$1000 fine if Mr. Luther does not appeal. The fine is due within 10 days of this ruling and Mr. Luther has 48 hours to appeal this decision to the OSRC.

***Status as of 7/6/2023 - Subsequent Ruling - Mr. Luther did not appeal this ruling so his penalty is just reduced to a \$1000 fine.***

PA Code Title 7-203.22(a), 203.22(b), 401.2(a)(1), 401.3(a)(b) Linda Schadel was the trainer of the horse TOPVILLE OLYMPIAN in race 3 on April 2, 2023 at Pocono Downs. Sample #404427 collected post race was found to contain Capsaicin. This is in violation of PA medication rules. As the trainer, Linda Schadel is responsible for the positive test and is fined \$250 (due within 10 days of ruling). TOPVILLE OLYMPIAN finished 1st in this race but has been disqualified. Purse money earned (\$5,250) must be returned within 10 days of this ruling. Mitigating factors were considered in the determination of this penalty. Mrs. Schadel has waived the right to appeal this ruling.

Sample #404592 collected post race was found to contain Capsaicin. This is in violation of PA medication rules. As the trainer, Linda Schadel is responsible for the positive test and is fined \$250 (due within 10 days of ruling). TOPVILLE OLYMPIAN finished 1st in this race but has been disqualified. Purse money earned (\$4,500) must be returned within 10 days of this ruling. Mitigating factors were considered in the determination of this penalty. Mrs. Schadel has waived the right to appeal this ruling.
