Blood sample #913174 was provided by #5 HC Commander, who finished 1st on 6/3/23 at Scioto Downs, and was trained by Mr. Holton. A first offense of Omeprazole Sulfide in Ohio is just a warning, thus Mr. Holton is issued the warning. Mr. Holton waived his right to a hearing, split sample and appeal.
