REFUSAL TO COOPERATE WITH AUTHORITIES DURING AN INVESTIGATION

71 IAC 10-2-3(a) Licensee Gregory Kain is hereby summarily suspended for failing to cooperate with Indiana Horse Racing Commission investigators regarding his wife's actions in the test barn following race 9 at Hoosier Park on 6/24/2023. Mr. Kain shall remain suspended until he has a formal hearing with the judges at Hoosier Park. During the period of this suspension Mr. Kain is denied access to all grounds under the jurisdiction of the Indiana Horse Racing Commission.

Status as of 7/14/2023 - Subsequent Ruling - 71 IAC 10-2-3(a), 71 IAC 5-1-26(a), 71 IAC 5-1-26(b) Licensee Gregory Kain had a hearing over telephone with the judges at Hoosier Park on 7/13/2023 to discuss his actions in the paddock area on 6/24/2023. After considering the testimony from Mr. Kain, the judges determined that Mr. Kain's summary suspension shall be ended and that he be restored to good standing in the state of Indiana immediately. Mr. Kain is still denied access to the test barn during the remainder of the 2023 meet at Hoosier Park.

205 CMR 3.29. On 06/11/2023 Industrial Labs reported to the Massachusetts Gaming Commission/Racing Division the Post Race result of Blood Sample E545691. This sample was collected from the horse NORTHERN SULTAN on 06/26/2023 who competed in Race 11 at Plainridge Park Racecourse and finished 1st. The sample revealed the presence of Methocarbamol, confirmed in the blood at 5.47 ng/mL. The measure uncertainty is 0.5 ng/mL at the threshold of 1 ng/mL. Trainer of record Vartan Krikorian waived his right to a split sample and a hearing was conducted on 07/18/2023. As a result trainer Vartan Krikorian is hereby fined the sum of \$1,000.00 in addition to loss of purse which is the sum of \$4,000.00. All monies forfeited must be returned within 10 days of ruling. The fine must be paid by Monday 07/24/2023.

found to contain Pemoline. A split sample was tested by The UIC Analytical Forensic Testing Laboratory and the presence of Pemoline was confirmed. As the trainer, Mr. Mullet is responsible for the positive test. Mr. Mullet is fined \$750 (fines are due within ten days of ruling) and issued a fifteen-day full suspension. The fifteen-day full suspension will be held in abeyance; if Mr. Mullet has no major medication violations within six months of this ruling, he will not have to serve this suspension. Mitigating factors were considered in the determination of the penalty. CAVIAR'S YANKEE finished 1st in this race but has been disqualified. Purse money earned (\$4,400) must be returned within ten days of this ruling. Mr. Mullet has waived his hearing/appeal rights.
