POSITIVE TEST- POST RACE

Anthony Alagna was the programmed trainer of the horse #8 ODD`S ON ST LUCIE when it competed in the 9th race on Friday, February 28, 2020. ODD`S ON ST LUCIE finished 2nd in the 9th race and as result, submitted a post-race urine sample for analysis. The urine sample collected identified the presence of the prohibited substance Gabapentin. Mr. Alagna per N.J.A.C 13:71-23.4(d) requested a split sample of the post-race urine sample collected be sent to the Texas A & M Medical Diagnostic Laboratory. Gabapentin was detected in the sample LC-MS/MS at a concentration of 9.3+ 2.0 nanograms per milliliter. The presence of Gabapentin in the horse #8 ODD`S ON ST LUCIE is in direct violation of the New Jersey Racing Commission rule N.J.A.C.13:71-23.1. Consistent with N.J.A.C.13:71-23.7, the horse #8 ODD`S ON ST LUCIE is hereby disqualified from sharing in the purse from the 9th race on Friday, February 28, 2020. The purse is hereby ordered to be redistributed among the remaining finishers.

Status as of 8/23/2023 - Stay - Anthony Alagna withdrew his appeal in Anthony Alagna v. New Jersey Racing Commission, OAL Docket No. RAC-07844-2020N, which resulted in the OAL returning his case file to the New Jersey Racing Commission. At issue in the appeal was Ruling No. 20MDH49 in which the Board of Judges at the Meadowlands Racetrack imposed a forty-five day suspension, \$1,000 fine, disqualification of the horse "Odd's On St Lucie," loss of purse and 2 MMV points for violation of N.J.A.C. 13:71-23.1, and N.J.A.C. 13:71-23.6(a)(b)(c)(d) in connection with a post-race positive test result revealing the presence of Gabapentin in the horse

"Odd's On St Lucie" after the 9th race on Friday, February 28, 2020. In Ruling No. 23TRH27, dated August 2, 2023, the New Jersey Racing Commission ("NJRC") ordered the imposition of the forty-five day suspension, \$1,000 fine, disqualification of the horse, loss of purse and 2 MMV points. By letter dated August 18, 2023, counsel for Mr. Alagna informed the NJRC that the appeal had been mistakenly withdrawn from the OAL. As a result, the NJRC hereby vacates Ruling No. 23TRH27 and has retransmitted Mr. Alagna's appeal of Ruling No. 20MDH49, dated August 5, 2020, to the OAL for a de novo hearing. The stay of the penalties originally granted in Ruling No. 20TRH18, dated August 12, 2020, remains in place.

An analysis performed by the UIC Forensic Lab of the blood sample (sample #138081), obtained from the Char The Star, 1st place finisher in 1st race at Du quoin on 30 June 2023, revealed the presence of Flunixin at a concentration of 255.2 +/-35.7 ng/ml. The threshold for Flunixin in the state of Illinois is 5 ng/ml. Pursuant to USTA rule 21.06 (Trainer Absolute insurer), USTA rule 21.08 (Purse Forfeiture) and USTA rule 21.01 (Testing of horses), Trainer Jill Brown is hereby fined \$1000, which has been paid, Char The Star shall be disgualified, and the purse shall be redistributed as follows: Char The Star 1 pl Dg, Mango Bud 2 pl 1, Katdemic 3 pl 2, Hawkeye Dewey 4 pl 3, Fear The Soldier 5 pl 4, Loyztrotnbro 6 pl 5.

POSITIVE TEST- POST RACE

As a result of the administrative hearing conducted on June 8, 2023 the Board of Judges has determined that: New Jersey Racing Commission ("NJRC") licensee, Nik Drennan was the programmed trainer of the horse "Sweet Soul David" when it competed in the 9th race at Freehold Raceway on Friday, January 13, 2023; The horse "Sweet Soul David" finished 1st in the 9th race on January 13, 2023; Following its performance in the 9th race at Freehold Raceway on January 13, 2023 the horse "Sweet Soul David" was selected to submit blood and urine samples for analysis; The blood sample collected from the horse "Sweet Soul David" on January 13, 2023 identified the presence of the substance Dexamethasone above the allowable threshold; The presence of Dexamethasone above the allowable limits in the horse "Sweet Soul David" on January 13, 2023 is in direct violation of NJRC rule N.J.A.C. 13:71-23.1; Mr. Drennan, per N.J.A.C 13:71-23.4(d), requested a split sample of the post-race blood sample collected on "Sweet Soul David" from the 9th race on January 13, 2023 be sent to Texas A&M Veterinary Medical Laboratory. The lab at Texas A&M Veterinary Medical Laboratory confirmed the presence of Dexamethasone in the sample above the allowable threshold; As a trainer licensed by the NJRC, Mr. Drennan; is the absolute insurer of and responsible for the condition of a horse within his care and custody; shall not enter or start a horse that has in its body any drug or substance foreign to the natural horse; has the duty to be familiar with medication rules of the Commission and with any drug or substance foreign the natural horse administered to said horse at his direction or while in his custody and care; As a result of the positive post-race blood analysis, Mr. Drennan is in violation of N.J.A.C. 13:71-23.1(a)(b)(c)(d), N.J.A.C 13:71-23.4(d), N.J.A.C 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13.71-23.7(a)(b) as such, Mr. Drennan is suspended for a period of fiftee Status as of 8/17/2023 - Stay

POSITIVE TEST- POST RACE

OSRC 3769-18-01-B(1,10,13,15,16), 3769-18-02, 3769-17-43. Blood sample #915194 was tested by the Ohio Dept. of Agriculture ATL and was found to contain Prednisolone, a Class 4 drug, at a concentration of 3.46 nanograms per milliliter of plasma, which exceeds the Regulatory threshold of 1 nanogram per milliliter adopted by the OSRC. Blood sample #915194 was provided by #6 Rose Run Yolanda, who finished 1st in race 2 on 5/6/23 at Miami Valley Raceway, and was trained by Mr. Luther. Mr. Luther requested a split sample that came back at 17.8 nanograms per milliliter of plasma, and DNA that proved a match. A hearing was conducted at Scioto Downs on 8/22/23 and Mr. Luther was given a \$1000 fine and a 15 day full suspension (08/30/23-09/13/23), which will be reduced to a 7 day full suspension (08/30/23-09/05/23) if not appealed. #6 finished 1st, is disgualified and placed 7th, and the purse (\$27,500) is to be returned and redistributed. Both the fine and purse are due within 10 days of this ruling. During his suspension, Mr. Luther is denied access to all grounds sanctioned by the OSRC, and all horses owned and/or trained by Mr. Luther may only be transferred by the judges or the OSRC. Mr. Luther has 48 hours to appeal this decision to the OSRC. This is Mr. Luther's second medication violation in the last 365 days.

As a result of the hearing, the Board of Judges has determined that: NJRC licensee, Brandon Mongiello was the programmed trainer of the horse "Here Comes Red" when it competed in the 9th race at Freehold Raceway on 5/12/23; The horse finished 1st in the 9th race and was selected to submit blood and urine samples for analysis; The blood sample collected identified the presence of the prohibited substance Orphenadrine which is in direct violation of N.J.A.C. 13:71-23.1; As a trainer licensed by the NJRC, Mr. Mongiello; is the absolute insurer of and responsible for the condition of a horse within his care and custody; Mr. Mongiello is found to be in violation of N.J.A.C 13:71-23.6(a)(b)(c)(d). As a result, Mr. Mongiello is hereby issued a full suspension for a period of 15 days, 8/25/23 through and including 9/8/23 and fined the sum of \$500.00 which must be received by the NJRC on or before 9/8/23. During the period of suspension, Mr. Mongiello is denied access to all grounds under NJRC jurisdiction. Pursuant to N.J.A.C. 13:71-23.7, the purse monies earned by "Here Comes Red" on 5/12/23 are ordered to be held pending the timely filing of an appeal. Should an appeal be filed, the purse monies earned by the horse "Here Comes Red" on May 12, 2023 shall be held pending a final decision by the NJRC. Should no appeal be filed in accordance with N.J.A.C. 13:71-3.4 the purse monies earned by "Here Comes Red" on 5/12/23 shall be redistributed in accordance with the official order of finish. In addition to the penalty issued herein, 2 Multiple Medication Violation (MMV) points by the Association of Racing Commissioners shall be assigned as a result of this violation. Mr. Jessie Pacheco was the driver of #1 Editorial in the 7th Race on 8/20/2023. Mr. Jessie Pacheco did drive in a careless, reckless, or unsatisfactory manner and failed to maintain complete control of his horse at all times by repeatedly driving his horse in the back of the driver of #2, Violating MN Rule 7884.0260 Subp 2 – K. Then while in the stretch Mr. Jessie Pacheco steered his horse in a manner that is deemed carless and reckless. Mr. Jessie Pacheco has been spoken to numerous times and has already received a 3 Day Driving Suspension for the same infraction. Due to aggravating circumstances and this being the 2nd Violation the penalty is a 9 Day Driving Suspension, dates are as follows, 8/22/2023 – 8/31/2023 – 9/3/2023 – 9/7/2023 – 9/10/2023 – 9/12/2023 – 9/15/2023 – 9/16/2023. positive finding of Methocarbamol at a higher level than the allowable threshold of 1 ng/ml. "Gimme Some Lovin" finished 1st is hereby disqualified and placed 8th. All purse monies paid must be returned and redistributed. Having appeared before a representative of the NYSGC and waiving the right to a formal hearing and appeal, the suspension is hereby reduced to 3 days and the fine is reduced to \$500. The horse "Gimme Some Lovin" will be required to submit a negative sample for the above-mentioned substance before being allowed to participate in further racing in New York. During the term of suspension, Mr. Parker will be denied the privilege of and access to all grounds under the jurisdiction of the NYSGC. All horses owned or trained by Mr. Parker shall be denied the privilege of participating in any racing in New York during the term of suspension. (1st offense in this category in a 365 day period.)

TAKE UP ABRUPTLY/SIT DOWN IN FRONT OF HORSES CAUSING CONFUSION AMONG TRAILING HORSES

On 7/25/23 during the 1st Race, Mr. Nick Roland was the driver of #3 Bankers Grace and is being charged with not maintaining a pace comparable to the class and causing confusion to the trailing horses, MN Rule 7884.0260 Subp 2 - I & MN Rule 7884.0260 Subp 2 - L. These actions were due to Mr. Nick Roland going the first guarter in 29.3, the second quarter in 33.0, then the third quarter in 30.0, and the final quarter of the race was 30.3. The horse Mr. Nick Roland was driving, #3 Bankers Grace finished fourth. The trainer of #3 Bankers Grace had 2 other horses in the 6-horse field, one of those finished 1st, while the other finished 3rd. Mr. Nick Roland was served a Notice of Hearing for 4:15pm in the

Due to the fact this is Mr. Nick Roland's 4th Offense of this nature in 2023 in Minnesota the Board of Judges all agree that Mr. Nick Roland's actions are not in the best interest of racing and Suspend Mr. Nick Roland for a total of 6 driving days as follows, 7/30/2023 – 8/1/2023 – 8/3/2023 – 8/6/2023 – 8/8/2023 – 8/10/2023. Mr. Nick Roland has 120 Hours to appeal this decision in writing to the Executive Director of the MRC.
