#### CONDUCT DETRIMENTAL TO THE NEST INTEREST OF HORSE RACING

On April 12,2022 the investigative staff of the New Jersey Racing Commission (N.J.R.C.) did conduct a routine stable inspection at Legend Farm which is located in Wrightstown New Jersey. Legend Farm is an off-track training facility that is licensed by and under the jurisdiction of the NJRC. An administrative hearing regarding this stable inspection was conducted on June 1, 2023, before the board of Judges at The Meadowlands Racetrack. As a result of the evidence and testimony presented in this administrative hearing, the Board of Judges have determined that Brett Ecker was in violation of various rules and regulations of the N.J.R.C. Brett Ecker did work in the capacity of caretaker of Standardbred horses while on the grounds of Legend Farm. As promulgated in N.J.A.C. 13:71-7.1(a) 4 and 13:71-7.26, the position of caretaker of Standardbred horses while on a licensed facility requires licensure by the N.J.R.C. Brett Ecker was not licensed by the N.J.R.C. while working with Standardbred racehorses and did provide false and misleading

information to members of the NJRC investigative Staff during the course of an investigation. These actions are in direct violation of N.J.A.C. 13:71-26.7. As a result of these actions, Brett Ecker is hereby fined the sum of two thousand-five hundred (\$2,500.00) dollars and is suspended for a period of one (1) year. The period of suspension shall begin on October 1, 2023, and continue through October 1, 2024, inclusive. During the period of suspension Mr. Ecker is denied access to all grounds that are under the jurisdiction of the NJRC for any and all purposes. As Mr. Ecker is not currently licensed in calendar year 2023, the suspension will be treated as a period during which he is ineligible for licensure with the N.J.R.C. # POSSESSION OF HYPODERMIC NEEDLES, SYRINGES AND/OR INJECTABLE AND/OR OTHER DRUGS

An administrative hearing was conducted on August 3, 2023, in the Judges office at the Meadowlands Racetrack the purpose of which was to receive evidence and testimony regarding a routine inspection of New Jersey Racing Commission ("N.J.R.C.") licensed trainer Brandon Mongiello`s stabling area located at Crystal Brook Training Center, an off-track stabling facility licensed by and under the jurisdiction of the N.J.R.C. The possession of hypodermic needles, syringes and instruments used for injection by someone other than a veterinarian licensed by the N.J.R.C. on a facility licensed by and under the jurisdiction of the N.J.R.C., is in direct violation of N.J.A.C. 13:71-1.19, N.J.A.C. 13:71-7.29 (a) 13, N.J,A.C. 23.6 (c) (d) and N.J.A.C. 13:71-23.9. As a result, Mr. Mongiello is hereby issued a full suspension of his NJRC license for a period of six (6) months and is fined the sum of one-thousand (\$1000.00) dollars; In addition to possessing hypodermic needles, syringes and instruments used for injection, Mr. Mongiello was also in possession of injectable substances and prescription legend drugs in his stabling area. The possession of injectable substances and prescription legend drugs by someone other than a veterinarian licensed by the N.J.R.C. on a facility licensed by and under the jurisdiction of the N.J.R.C. is in direct violation of N.J.A.C. 13:71-1.19, N.J.A.C. 13:71-7.29 (a) 13, N.J.A.C. 13:71-23.6 (c) (d), and N.J.A.C. 13:71-23.9. # **POSITIVE TEST- POST RACE**

Mike Terpolilli was the programmed trainer of the horse "Tisadream N" when he raced in the 5th race at the Meadowlands on July 21, 2023.
