James Clouser Jr was trainer of the horse MAJOR ASSET in the 3rd Race at Buffalo Raceway on April 5th, 2023. Post race analysis of sample CV3543236 showed the presence of TESTOSTERONE above the threshold permitted by the Commission, which was confirmed by split sample. MAJOR ASSET finished 2nd, is disqualified and placed 7th. All purse monies earned shall be returned and redistributed (purse returned), and the horse must submit a negative test prior to entering to race (negative test submitted). Having appeared before a representative of the NYSGC and waiving his right to a formal hearing and right to appeal, Mr Clouser's 30 day suspension and \$1000 fine is hereby reduced to a 15 day full suspension and \$500 fine. The suspension shall be served October 21, 2023

through and including November 4th, 2023. During the term of suspension, Mr Clouser is ruled off all grounds under the jurisdiction of the NYSGC and deemed a disqualified person. No trainer transfer of horses in his care will be permitted without the approval of the presiding judge.

Blood samples drawn (post-race) from CONTANGO HANOVER were tested and found to contain Lamotrigine. As the trainer Mr. Daugherty, Jr. is responsible for the positive test. However, evidence has been presented to show that there is a reasonable chance that this positive was a result of environmental contamination. This does not excuse Mr. Daugherty, Jr. from responsibility for the positive test, as he is responsible for protecting the horse from such exposure, but it was considered a mitigating factor in determining the penalty. CONTANGO HANOVER finished 1st in the 4th race on July 30, 2023, but is disqualified. Purse money earned (\$2,650) has been returned. Mr. Daugherty, Jr. is fined \$1,500 (fine has been paid). Mr. Daugherty, Jr. has waived his appeal rights.

Post race analysis of sample 355596 showed the presence of OXYCODONE (Class 1A). Mr. Lebo waived his split sample rights. SPEAKING OF COFFEE finished 4th and is disqualified. Mr. Lebo is hereby fined \$10,000 and issued a full suspension of 365 days beginning October 13, 2020 through and including October 12, 2021 and ordered to return all purse monies earned from the above race within 10 days of this ruling. During the term of suspension, Mr. Lebo is ruled off all grounds under the jurisdiction of the PSHRC. Any trainer transfers must be approved by the Judges at The Meadows. SPEAKING OF COFFEE is placed on the Steward's List for 90 days beginning October 8, 2019. Mr. Lebo has 10 days to appeal this decision to the PSHRC, Bureau of Standardbred Racing.

Status as of 2/7/2020 - Subsequent Ruling - RULING# 20004C The State Horse Racing Commission (Commission) reviewed newly received evidence from Justin Lebo and Chester Lebo wherein Chester Lebo substantially proved and accepted partial responsibility for the violations in the below listed rulings, and pursuant to a mutual agreement and in consideration of the withdrawal of Justin's appeals of Commission Rulings Nos. 19002F and 19127M, the Commission hereby amends said rulings as follows: Justin Lebo will receive a 60 day suspension and a \$1,500.00 fine. The truck that was sent was incorrect for the job, making the track worse (hole and dip in the first turn) causing several horses to break stride. This behavior is detrimental to the sport; the language used was insulting, vulgar and uncalled for.

During her suspension Mrs. Johansson is denied the use and privileges of all grounds sanctioned by the OSRC. All horses trained by Mrs. Johansson are suspended and may only be transferred with permission from the judges or the director at the OSRC. If the fine is not paid and purse is not returned to the judges by 11/13/2019 you may be suspended or your licensed revoked

Status as of 7/26/2023 - Subsequent Ruling - The Adjudication Order from January 18, 2023 by the Ohio State Racing Commission is reversed; it is not in accordance with law, because the Commission failed to apply the gabapentin screening limit, which applied to all test reported to the Commission on and after October 30, 2019, irrespective of the date of the subject race. The final test for gabapentin in MANCHEGO's blood was reported to the Commission on November 19, 2019, and was well below the screening limit. That test was negative for gabapentin under Commission rules, and the Commission was required to treat it as such. Shane Tritton was the programmed trainer of the horse SPRINGSTEEN when he raced in the 14th race at the Meadowlands Racetrack on February 11, 2023. Following this race, SPRINGSTEEN was required to submit blood and urine samples for analysis. A report from Industrial Laboratories identified the presence of Phenylbutazone above the allowable limits. This is in direct violation of N.J.R.C. 13:71-23.8(f). At Mr. Trittons` request, split

sample testing was performed at an independent laboratory and the presence of Phenylbutazone, above the allowable limits was confirmed. Mr. Tritton has waived his right to a hearing with the Board of Judges. As a result, Mr. Tritton is issued a full suspension of his New Jersey Racing Commission license for a period of fifteen (15) days and fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on October 30,2023 and run through November 13, 2023. inclusive. During the period of suspension, Mr. Tritton is denied all access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. Consistent with N.J.A.C.13:71-23.7, the horse SPRINGSTEEN is hereby disqualified from sharing in the purse from the 14th race on February 11, 2023. The payment of the fine associated with this ruling must be received by the New Jersey Racing Commission on or before November 13, 2023.
