For the above reasons, you are hereby declared ineligible for membership with the United States Trotting Association.

ANY ACT OF CRUELTY TO A HORSE

OSRC 3769-12-26-A(9&10). A video was sent to the office of the Ohio State Racing Commission which shows Mr. Lupton engaging in an act of cruelty to a horse. After a hearing in the judges office at Dayton Raceway on 10/19/23, at which Mr. Lupton appeared along with counsel, Mr. Lupton is fined \$1000 and given a 365 day suspension (10-25-2023 through 10-23-2024) for engaging in an act of cruelty to a horse and for conduct against the best interest of horse racing. This case is also referred to the OSRC for any further penalty they may deem necessary. The fine is due within 10 days of the ruling. During his suspension, Mr. Lupton is denied the use and privileges of all the grounds sanctioned by the OSRC. Mr. Lupton has 48 hours to appeal this decision to the OSRC.

Blood and urine samples collected (post-race) from BAPTISM were tested and found to contain PHENYTOIN. Split samples were tested by The Texas A&M Veterinary Medical Diagnostic Laboratory and the presence of PHENYTOIN was confirmed. As the trainer Mr. Svanstedt is responsible for the positive test. BAPTISM finished first but has been disqualified. Purse money earned (\$10,000) must be returned within ten days of this ruling. Mr. Svanstedt is fined \$1,000 (fines are due within ten days of ruling) and has waived his hearing and appeal rights. Mitigating factors were considered in the determination of this penalty.

Blood samples drawn (post-race) from ROSE RUN ZEKE were tested and found to contain Lamotrigine. As the trainer Mr. York is responsible for the positive test. However, evidence has been presented to show that there is a reasonable chance that this positive was a result of environmental contamination. This does not excuse Mr. York from responsibility for the positive test, as he is responsible for protecting the horse from such exposure, but it was considered a mitigating factor in determining the penalty. ROSE RUN ZEKE finished 1st in The Meadows' 9th race on July 29, 2023, but is disqualified. Purse money earned (\$10,174) must be returned within ten days of this ruling. Mr. York is fined \$1,500 (fines are due within ten days of ruling). Mr. York has waived his appeal rights.
