## **POSITIVE TEST- POST RACE**

OSRC 3769-18-01-B(4d,10&13), 3769-18-02, 3769-17-43. Blood sample #911018 was tested by the Ohio Dept. of Agriculture ATL and showed a TCO2 concentration of 39.8 millimoles per liter of serum, which exceeds the regulatory threshold of 37 millimoles per liter adopted by the OSRC. Blood sample #911018 was provided by #3 Bettor Of The West, who finished 1st in race 11 on 2/28/23 at Miami Valley Raceway, and was trained by Mr. Galliers. #3 is disqualified and placed 10th, and the purse (\$7000) is ordered to be returned and redistributed. The fine of \$1000 and purse must be paid within 10 days of this ruling. This is Mr. Galliers 2nd medication violation within the last 365 days. He is given a full 60

days (4-11-23 thru 6-09-23) suspension, or a full 30 days (4-11-23 thru 5-10-23) if not appealed. During his suspension, Mr. Galliers is denied the use and privileges of all grounds sanctioned by the OSRC. All horses owned and/or trained may only be transferred by the judges or the OSRC. Mr. Galliers has 48 hours to appeal this decision to the OSRC. Status as of 12/2/2023 - Subsequent Ruling - Mr. Galliers has chosen to drop his appeal of ruling 23-MVR-109 and will serve a full 30 day suspension (12/08/23-01/06/24) and pay a \$1000 fine. The purse winnings of \$7000 must be returned and made available for redistribution to Miami Valley Raceway by December 12, 2023. The fine must be paid to the OSRC also by December 12, 2023. ## POSITIVE TEST- POST RACE

Jim King, Jr. was the programmed trainer of the horse WALL OF BLUE when she raced in the 4th race at the Meadowlands Racetrack on May 6, 2023. Following this race, WALL OF BLUE was required to submit to a blood sample for analysis. A report from Industrial Laboratories, identified the presence of the drug Hydroxydantrolene. At Mr. King, Jr.'s request, a split sample was analyzed at an approved independent laboratory and did confirm the presence of Hydroxydantrolene. This is in direct violation of various rules and regulations of the New Jersey Commission. Mr. King, Jr. is issued a full suspension of his New Jersey Racing Commission license for a period fifteen (15) days and also fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on December 15, 2023 and run through December 29,2023 inclusive. During the period of suspension, Mr. King, Jr. is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. However, evidence has been presented to show that there is a reasonable chance that this positive was a result of environmental contamination. This does not excuse Mr. Kozar from responsibility for the positive test, as he is responsible for protecting the horse from such exposure, but it was considered a mitigating factor in determining the penalty. NIGHT LEGS finished 1st in this race, but is disqualified. Purse money earned (\$3,200) must be returned within ten days of this ruling. Mr. Kozar is fined \$250 (fines are due within ten days of ruling) and has waived his hearing/appeal rights.
