AMENDED Jennifer Bongiorno was the programmed trainer of the horse DONATO PATRIOT K when he raced in the 4th race at the Meadowlands Racetrack on January 20, 2023. Following this race, DONATO PATRIOT K was required to submit blood samples for analysis. A report from Industrial Laboratories identified the presence of Dexamethasone above the allowable limits. As a result, Ms. Bongiorno is issued a full suspension of her New Jersey Racing Commission license for a period of fifteen (15) days and fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on July 25, 2023 and run through August 8, 2023. inclusive. During the period of suspension, Ms. Bongiorno is denied all access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. Consistent with N.J.A.C.13:71-23.7, the horse DONATO PATRIOT K is hereby disqualified from sharing in the purse from the 4th race on January 20, 2023. The payment of the fine associated with this ruling must be received by the New Jersey Racing Commission on or before August 8, 2023. Status as of 3/12/2024 - Amendment - Jennifer Bongiorno withdrew her appeal in Jennifer Bongiorno v. New Jersey Racing Commission, OAL Docket No. RAC 06968-2023N, which resulted in the OAL returning her case file to the New Jersey Racing Commission. At issue in the appeal was Ruling No. 23MDH87, dated June 27, 2023 in which the Board of Judges at Meadowlands Racetrack imposed a 15 day suspension, \$500.00 fine, disqualification of the horse "Donato Patriot K" and 1/2 MMV point for violation of N.J.A.C. 13:71-23.1(a)(b)(14), N.J.A.C. 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13:71-23.7(a)(b)(c)(d) in connection with a post-race positive test result revealing the presence of Dexamethasone in the horse "Donato Patriot K" after the 4th race on January 20, 2023. Ms. Bongiorno appealed the decision of the Board of Judges and requested a stay of the penalties. By Ruling No. 23TRH26, dated July 20, 2023, a stay was granted and the matter was transmitted to the Office of Administrative Law as a contested case. Having withdrawn her appeal, the penalties issued in Ruling No. 23MDH87 by the Board of Judges at Meadowlands Racetrack are reinstated. Ms. Bongiorno is hereby issued a 15 day suspension, fined \$500.00 and 1/2 MMV points are imposed. Said suspension will be served from February 2, 2024 through and including February 16, 2024. Payment of the \$500.00 fine is due on or before February 16, 2024. The horse "Donato Patriot K" is hereby disqualified from sharing in the purse from the 4th race on January 20, 2023 at Meadowlands Racetrack. The Horsemen's Bookkeeper is hereby ordered to redistribute the purse monies from the 4th race on January 20, 2023 at Meadowlands Racetrack accordingly. This matter is hereby referred to the Board of Judges for a hearing to determine if further disciplinary action is warranted in the event Ms. Bongiorno fails

UNSATISFACTORY DRIVE - CARELESSNESS

An administrative hearing was conducted on January 18, 2024 to accept evidence and testimony relating to a racing incident which Kubi Erzene was involved in during the 3rd race on Friday, January 12, 2024 at Freehold Raceway. As a result of the administrative hearing, the Board of Judges have determined that: New Jersey Racing Commission ("NJRC") licensee, Kubi Erzene was the driver of the horse "Miss Bombsaway" when it competed in the 3rd race at Freehold Raceway on Friday, January 12, 2024; During the stretch drive of the 3rd race, Mr. Erzene did fail to drive his horse, "Miss Bombsaway," to the finish line of the race, therefore failing to take full advantage of racing opportunities in the stretch. Not only did Mr. Erzene fail to drive his horse to the finish, he "grabbed up" just before the finish costing his horse a winning performance. Whether this action was intentional or due to gross carelessness, it affected the outcome of the race in the most egregious manner and negatively impacted those patrons who wagered on the horse. Mr. Erzene failed to conduct himself in a forthright and professional manner. Mr. Erzene's actions constitute conduct detrimental to the sport that undermined the integrity of racing and the pari-mutuel wagering thereupon. Mr. Erzene is in violation of N.J.A.C. 13:71-7.29(a)13 - Conduct detrimental to the sport N.J.A.C. 13:71-20.10(a), (b) Fradulent or unsatisfactory drive Having considered the severity of the incident on Friday, January 12, 2024, Mr. Erzene is hereby issued a suspension of his NJRC driving license for a period of one year (365 days). The said suspension shall begin on Friday, February 16, 2024 through and including Saturday, February 15, 2025.

Mr. Foulk is fined \$1000 and given a 365 day full suspension from 03/07/2024-03/06/2025. The suspension will be reduced to a 180 day full suspension 03/07/2024-09/02/2024, if not appealed. During his suspension, Mr. Foulk is denied the use and privileges of all the grounds sanctioned by the OSRC.
