# **POSITIVE TEST- POST RACE**

Samantha Dubois, as trainer of record for the horse "J-S PERFECT CACHE" on 03/19/2024 at Saratoga Harness, having appeared before a representative of the New York State Gaming Commission, and waiving the right to a formal hearing and the right to appeal, and waiving the right to a referee sample test, is issued a Twenty (20) day full suspension of their occupational license (reduced to Ten (10) days without appeal), beginning 04/10/2024, through and including 04/29/2024, and a One Thousand Five Hundred Dollar (\$1,500.00) fine (reduced to Seven Hundred Fifty Dollars (\$750.00) without appeal. ### OTHER

On or about March 10, 2020, the New Jersey Racing Commission ("NJRC") received a copy of the federal indictment issued against Rebecca Anne Linke by the United States District Court for the Southern District of New York in United States v. Jorge Navarro et al. The charges in the indictment were directly related to the horse racing industry. In Ruling No. 20TRH8, dated March 10, 2020, the NJRC suspended all licenses issued to Rebecca Anne Linke, effective March 13, 2020, pursuant to N.J.A.C. 13:71-26.9. On or about January 4, 2024, Rebecca Anne Linke provided the NJRC with a Nolle Prosequi, dated January 2, 2024, issued by the United States District Court for the Southern District of New York. Upon receipt of the Nolle Prosequi, the NJRC terminated the suspension of the NJRC licenses ordered in Ruling No. 20TRH8 as required by N.J.A.C. 13:71-26.9(d).
