#### LEAVING HORSE UNATTENDED

OSRC 3769-12-26-A(9&10), 3769-18-02. #9 Mel Rose Dunn, who raced in race 13 on 4/29/24 at Miami Valley Raceway, was left unattended in it`s assigned stall for hours after the last race was conducted and after the paddock was scheduled to be locked up for the evening. Another trainer was kind enough to take the horse back to a local fairgrounds and cared for the horse until it was picked up the following morning. Ms. Alexander was listed as the trainer on 4/29/24 and is responsible for not only the condition of the horse, but for making arrangements for getting the horse to where it should be. Ms. Alexander is fined \$1000 and given a full 30 day suspension (05/04/24-06/02/24), or the penalty will be reduced to the \$1000 fine and a full 10 day suspension (05/04/24-05/13/24), if not appealed. The fine is due within 10 days of this ruling. During the suspension, Ms. Alexander is denied the use and privileges of all the grounds sanctioned by the OSRC. All horses owned and/or trained by Ms. Alexander may only be transferred by the Judges at Scioto Downs or the OSRC. Ms. Alexander has 48 hours to appeal this decision to the OSRC.

#### POSITIVE TEST- POST RACE

Trainer Charlene Sharpe, for being the trainer of record on sample #E720322 taken from BACKWATER BELLE on April 2nd, 2024 at Rosecroft Raceway, was found to contain ADB-Fubinaca. As a result, Sharpe is fined \$2,500.00 and must return all purse monies. Sharpe will also be issued a full suspension from April 25th, 2024 through April 19th, 2025 (360 days). During this suspension, she and all horses trained and/or owned by her are barred from the grounds, under the jurisdiction of the Maryland Racing Commission. Additionally, BACKWATER BELLE is disqualified, finishing first and placed ninth, and is placed on the steward`s list from April 25th, 2024 through April 19th, 2025 (360 days). Once Sharpe's suspension is completed, she must reapply and receive approval from the Maryland Racing Commission to obtain licensure. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of the ruling. COMAR: 09.10.03.04.B. Six Multiple Medication Violation (MMV) points assessed.

Status as of 4/26/2024 - Appeal - Trainer Charlene Sharpe has appealed the ruling of the Rosecroft Raceway judges (RCR24-028) on April 25th, 2024.

## **MEDICATION PROCEDURE VIOLATION**

71 IAC 8-1-1.5(b)(3) Based on the unanimous adoption of the Administrative Law Judge's Proposed Findings of Fact, Conclusions of Law, and Non-Final Order by the members of the Indiana Horse Racing Commission at its November 30, 2023, meeting, Mr. Williams is suspended for a period one hundred eighty (180) days beginning on December 4, 2023,

through May 31, 2024, and fined a total of \$1,000.00 for violations contained in Administrative Complaint No. 222002, which include oral administration of substances, foreign or otherwise, to multiple horses on race day. During the period of this suspension Mr. Williams is denied access to all grounds under the jurisdiction of the Indiana Horse Racing Commission.
