POSITIVE TEST- PRE RACE

Misty Carey, as trainer of record for the horse "WICKED WISHES" in the 4th race on 04/22/2024 at Saratoga Harness is issued a Sixty (60) day full suspension of their occupational license, beginning 05/21/2024, through and including 07/19/2024, and a One Thousand Dollar (\$1,000.00) fine. The pre-race blood sample collected from "WICKED WISHES" on 04/22/2024 was found to have a TCO2 concentration of 41.3 millimoles per liter +/- 0.7 millimoles per liter. This is in excess of the levels established by the New York State Gaming Commission. "WICKED WISHES" was pulled up and did not finish. "WICKED WISHES" had no purse earnings in this race. "WICKED WISHES" shall submit to a 6-hour pre-race detention, for a period of 6 months, 05/21/2024 through 11/20/2024, without regard to whether the horse is transferred to a new owner or trainer. The horse must also test in compliance with the above stated rules each time raced during the required pre-race

detention period and shall be ineligible to race until the horse tests in compliance with this rule. During the term of the suspension, Misty Carey is deemed a disqualified person and denied access to all grounds under the jurisdiction of the New York State Gaming Commission. Any horses owned or trained by Misty Carey shall be denied the privilege of participating during the term of suspension, unless transferred to another licensee approved by the Presiding Judge at Saratoga Harness. (1st offense in this category).

POSITIVE TEST- POST RACE

Mass 205 CMR 3.29. On May 16, 2024 Industrial Labs reported to the Massachusetts Gaming/Racing Division, the Post-Race result of Blood Sample E572530, collected from the horse TOP RANK on 05/02/2024 who competed in Race 6 at Plainridge Park and finished 4th. It revealed the presence of Hydroxydantrolene confirmed in the blood at 215 pg/*mL. The measurement uncertainty of the method is 20pg/mL at the threshold of 100 pg/mL. Trainer of record Michael Graffam was notified of the finding on 5/20/2024 and on 05/21/2024 waived his rights to both a split sample and a formal hearing. As a result of the violation Mr. Graffam is hereby fined the sum of \$1,000.00. In addition the horse TOP RANK finished 4th and is disqualified. The purse monies won, \$760.00 is hereby ordered forfeited and returned for redistribution. Both purse monies forfeited and fine are payable by 05/28/2024.

Blood sample #917125 collected at Northfield Park on 1/20/24 from the horse Sunshine Queen was found to contain xylazine at a concentration of 1995+-36 picograms per milliliter of plasma. This exceeds the Regulatory threshold of 200 picograms per milliliter adopted by the OSRC. Ms. Murdock had a telephonic hearing with the judges on 5/19/24. She is hereby fined \$1000 and suspended 15 days. Sunshine Queen is disqualified, and as a result of the disqualification the purse is ordered to be returned (\$4750.00). The penalty will be reduced to 7 days suspension, \$500 fine and loss of purse if not appealed. O.S.R.C.-3769-18-01(B)(1),(10),(13),(15)&(16) 18-02 During her suspension Ms. Murdock is denied the use and privileges of all grounds sanctioned by the OSRC. Any horses that she wants to transfer to another owner of trainer must be approved by the judges or the OSRC. The fine and purse money must be returned by 5/29/24. Ms. Murdock has 48 hours to appeal this ruling.

FRAUDULENT ACTS RELATIVE TO RACING

Ms. Russell is suspended indefinitely until she appears before the Judges at Scioto Downs for a hearing concerning the possible fraudulent delivery of a coggins test result. Ms. Russell must also provide the original copy of the coggins test when she does appear. The Judges spoke to Ms. Russell and offered her different dates for a hearing, but so far she has declined.
