During the morning inspection on 5/27/2024 MRC Investigator Selena Sarter witnessed a groom for Mr. Bertrand to be nebulizing a horse name Dougsmonkeybusines who is into go 5/28/2024 in race #8. The groom also admitted to nebulizing Frewil Dakota Sven who is also in 5/28/2024 in race #2. This is a clear Violation of MN Rule 7890.0110 Subp 1 stating no person shall administer or cause to be administered to any horse within 48 of a race in which it is scheduled to run any medication by injection, oral, or topical administration, rectal infusion or suppository, or by inhalation. This also falls under MN Rule 7877.0170 Subp 2 - C - 2 sating no trainer may administer any medication within 48 hours. Both Dougsmonkeybusines and Frewil Dakota Sven have been scratched. The Penalty is \$500 per horse for a total of \$1000. Mr. Betrand did meet with the Judges in the Judges Office and did sign the Waiver of Hearing. Mr. Bertrand has 120 hours to pay the fine.

POSITIVE TEST- POST RACE

Trainer Richard D. Johnson was the programmed trainer of the horse HASHTAGMADEYALOOK when he raced in the 7th race at the Meadowlands Racetrack on Friday, June 12, 2020. Following the race, HASHTAGMADEYALOOK was required to submit blood samples for analysis. A report from ALS Global - Truesdail Laboratories identified the presence of Phenylbutazone above the allowable limits. This is in direct violation of N.J.R.C. 13:71-23.8(f). As a result, Mr. Johnson is issued a full suspension of his NJRC for a period of fifteen (15) days and fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on August 17, 2020 and run through August 31, 2020 inclusive. During the period of suspension, Mr. Johnson is denied all access to all grounds that are under the jurisdiction of the New Jersey Racing Commission for any and all purposes. Consistent with N.J.A.C.13:71-23.7, the horse HASHTAGMADEYALOOK is hereby disqualified from sharing in the purse from the 7th race on Friday, June 12 Status as of 2/6/2024 - Subsequent Ruling - On December 19, 2023, the New Jersey Racing Commission (NJRC) Executive Director issued Ruling No. 23TRH58 which

imposed a monetary fine against you in which payment was to be received by the NJRC not later than January 18, 2024. As you have failed to comply with terms of Ruling No. 23TRH58 by failing to pay the fine by the required due date, you are in violation of N.J.A.C. 13:71-1.20(b); 13:71-1.21. As a result, you are hereby suspended indefinitely until such time payment has been received by the NJRC. Said suspension shall be effective immediately.

The finding of Methocarbamol is evidence of a violation of the Commission Rule Chapter 11; therefore, this finding constitutes a positive test for the horse, Ranaldi. As a result of the administrative hearing conducted on April 25, 2024, in which the purpose was to accept evidence and testimony relating to the license application filed on January 22, 2023 by Greg Peck, the Board of Judges has determined that: New Jersey Racing Commission ("NJRC") applicant Greg Peck did fail to provide truthful, accurate information concerning his prior arrest record on his 2023 NJRC license application. NJRC State investigators furnished evidence of multiple arrest records, both in New Jersey and Pennsylvania, that Mr. Peck failed to disclose in his application. Having considered the evidence and testimony presented at this hearing, the Board of Judges has determined: Mr. Peck, having failed to disclose this information, violated the following NJRC rules; Mr. Peck is in violation of N.J.A.C. 13:71-7.2, N.J.A.C. 13:71-7.3, and N.J.A.C. 13:71-7.7 and, as such, Mr. Peck is suspended for a period of one year (365 days), from Sunday, July 7, 2024 through Sunday, July 6, 2025 inclusive. During the period of suspension, Mr. Peck is denied access to all grounds under the jurisdiction of the NJRC for any and all purposes. Mr. Peck is also fined the sum of two thousand (\$2,000.00) dollars. Payment of the fine associated with this ruling shall be received by the NJRC on or before July 6, 2025. Mr. Peck is not currently licensed by the NJRC. As a result, the suspension shall be served as a period of license ineligibility.

FRAUDULENT ACTS RELATIVE TO RACING

Ms. Russell is suspended indefinitely until she appears before the Judges at Scioto Downs for a hearing concerning the possible fraudulent delivery of a coggins test result. Ms. Russell must also provide the original copy of the coggins test when she does appear. The Judges spoke to Ms. Russell and offered her different dates for a hearing, but so far she has declined.

Status as of 5/30/2024 - Subsequent Ruling - Ms. Russell appeared before the Judges at Scioto Downs on 5/29/2024 and provided the original coggins test result for the horse, Super Spirit. As verified by the Ohio Department of Agriculture and the Michigan Diagnostics Lab, the original coggins test result was for a horse, Bettor's Choice, from May of 2023. The original that Ms. Russell provided has been tampered with and changed to say, the horse Super Spirit, along with other changes. For fradulent actions and conduct against the best interest in racing, Ms. Russell is fined \$1000 and given a 365 day full suspension (06/04/24-06/03/25) and referred to the OSRC for further action. The above mentioned penalty is the maximum that the Judges can give in Ohio. The Judges consider this a very severe violation. Ms.Russell could have put hundreds of horses at a health risk should the horse have

actually tested positive for equine anemia. The Judges request that the OSRC add to this penalty anything that they may deem appropriate. The fine must be paid within 10 days of this ruling. During her suspension, Ms. Russell is denied the use and privileges of all grounds sanctioned by the OSRC. All horses owned and/or trained by Ms. Russell may only be transferred by the Judges at Scioto Downs or by the OSRC. The horse, Super Spirit is also suspended from racing in Ohio unless released by the Judges at Scioto Downs or the OSRC. Ms. Russell has 48 hours to appeal this decision to the OSRC. OSRC 3769-2-26-A(4, 5, 10), 3769-2-29-A, 3769-2-99, 3769-17-33-A, 3769-17-30-B, 3769-15-32-C.
