## **#1 - "The Diane (Mum) Stevenson Memorial Claiming Pace"**

*1<sup>st</sup> Leg – Thursday, July 11<sup>th</sup>, 2024 – Claiming \$7,500 – Purse \$7,500*

*2<sup>nd</sup> Leg – Thursday, July 18<sup>th</sup>, 2024 – Claiming \$10,000 – Purse \$9,000*

*3<sup>rd</sup> Leg – Thursday, August 1<sup>st</sup>, 2024 – Claiming \$12,500 – Purse \$11,000*

*FINAL – Thursday, August 8<sup>th</sup>, 2024 – Non-Claiming – Purse \$12,500 Added*

**Declaration Fee – \$250 due by horses first start in series**

## **#2 - "The David Hill III Memorial Claiming Pace"**

*1<sup>st</sup> Leg – Thursday, August 15<sup>th</sup>, 2024 – Claiming \$10,000 – Purse \$10,000*

*2<sup>nd</sup> Leg – Thursday, August 22<sup>nd</sup>, 2024 – Claiming \$12,500 – Purse \$11,000*

*3<sup>rd</sup> Leg – Thursday, August 29<sup>th</sup>, 2024 – Claiming \$15,000 – Purse \$12,500*

*FINAL – Thursday, September 5<sup>th</sup>, 2024 – Non-Claiming – Purse \$15,000 Added*

**Declaration Fee – \$250 due by horses first start in series**

### **Conditions:**

- **All horses will be eligible to be claimed in all legs, with no claiming allowed in the Final(s)**
- *Maryland Owned, Sired, and Bred Bonus does not apply to these added money events*
- **Horses must start in 2 legs to be eligible to the Final**
- *No Nomination Fee is required*
- **\$250 Declaration Fee is required and due only with each horse's first start per series and will be added directly to the respective Series Final purse**
- **\$500 Claim Fee must be included with each claim submission.** *Said fee collected from each successful claim will be added directly to the respective Series Final purse*
- *Top 8 money earners in each series will race in the final*
- *If entries allow, a consolation will be offered in each series equal to the 1<sup>st</sup> Leg Claiming Price (\$7,500 for Series #1 and \$10,000 for Series #2)*
- *No more than 2 horses from any stable or common ownership permitted to race in each Final or Consolation combined (2 horses TOTAL per series)*
