Trainer Archie Buford, for being the trainer of record on sample #E604182 taken from ELOCUTIONIST in the 8th race on April 7th, 2024 at Shenandoah Downs, was found to contain the medication Boldenone. This was identified by Virginia Racing Commission laboratory Industrial Laboratories. At Buford's request, a split sample was sent to and analyzed by RMTC-approved Analytical Forensic Testing Laboratory, which did confirm the presence of Boldenone. As a result, Buford is fined \$500.00, and must return all purse monies. Additionally, he will be issued a 15-day full suspension from June 24th, 2024 through July 8th, 2024. During this suspension, he and all horses trained and/or owned by him are barred from the grounds, under the jurisdiction of the Virginia Racing Commission. ELOCUTIONIST is disgualified, finishing 2nd and was placed 8th. #### **POSITIVE TEST - ILLEGAL SUBSTANCE TEST**

DHRC Licensee Michael Cole, having had a Judges hearing on 6/24/2024, with aggravating and mitigating circumstances considered, is now under a 180 day Full suspension (6/19/2024 through and including 12/15/2024) and a \$2,000 fine for failing a human drug test (2nd violation within 2 years). Blood sample #918996 was tested by the Ohio Department of Agriculture ATL and was found to contain flunixin, a Class 4 drug, at a concentration of 32 nanograms per milliliter of plasma, which exceeds the Regulatory threshold of 20 nanograms per milliliter of plasma, adopted by the OSRC. Blood sample #918996 was provided by #4 Head To The Beach, who finished 1st in race 14 on 5/14/24 at Scioto Downs, and was trained by Mr. Crawford. #4 is disqualified and placed 10th, the purse earnings (\$3000) is ordered to be returned and redistributed accordingly. 
