### **FALSIFICATION OF LICENSE APPLICATION**

Mr. Felix has refused to appear for a hearing so he is fined \$500, or \$250 if not appealed, and placed on the Stop List in Ohio, and Indefinitely Suspended until he appears before the Judges. ### **POSITIVE TEST- PRE RACE**

Jen Giuliani, as trainer of record for the horse, "Play To The Crowd", in the 4th race on 05/29/2024 at Buffalo Raceway is issued a Sixty (60) day full suspension of their occupational license, beginning 06/19/2024, through and including 08/17/2024, and a One Thousand Dollar (\$1,000.00) fine. The pre-race blood sample collected from "Play To The Crowd" on 05/29/2024 was found to have a TCO2 concentration of 44.1 millimoles per liter +/- 0.7 millimoles per liter. This is in excess of the levels established by the New York State Gaming Commission. "Play To The Crowd" finished 2nd and is hereby disqualified and placed last. All purse money must be returned and redistributed. "Play To The Crowd" shall submit to a 6-hour pre-race detention, for a period of 6 months, 05/30/2024 through 11/30/2024, without regard to whether the horse is transferred to a new owner or trainer. The horse must also test in compliance with the above stated rules each time raced during the required pre-race detention period and shall be ineligible to race until the horse test. (1st offense in this category).

Mr. Koprowski is part owner of a horse named SIR CACTUS JAX. This horse qualified at the Meadows on April 23, 2024. Since Mr. Koprowski had no PSHRC owner`s license, an affidavit was signed by the trainer allowing SIR CACTUS JAX to qualify on that day. Mr. Koprowski is fined \$50 (fines are due within ten days of ruling) and is issued an indefinite suspension starting June 17, 2024. PA Code Title 7: 203.23(b) 203.11(a)(e) Chester C. Miller (F H L Farm) has failed to complete his Pennsylvania State Horse Racing Commission requirements. Mr. Miller was the owner of a horse named HOPINGFORTHECROWN that qualified on November 28, 2023 at The Meadows. Since Mr. Miller was not licensed at that time an affidavit was signed, so the horse was allowed to qualify. Even though Mr. Miller sold HOPINGFORTHECROWN on December 6, 2023, he was still the owner, according to USTA records, on November 28, 2023. Mr. Miller is fined \$50 (fines are due within ten days of ruling) and issued an indefinite full suspension starting June 17, 2024. ### **POSITIVE TEST- POST RACE**

MGCB Ruling 7659 - Todd Pappas was the trainer of record of the horse Rockin TJ, winner of Race 2 on 11/11/2023 at Northville Downs, when the post-race sample was found to contain N-Ethyl Nicotinamide (a metabolite of nikethamide). Penalty of \$10,000.00 fine, a one-year suspension, to be served 1/07/2024 through and including 1/05/2025, and loss of purse. During this time, Todd Pappas is denied the privileges of all grounds live and/or simulcast under the Horse Racing Law of 1995 as amended. All horses owned or trained by Todd Pappas are ineligible to participate at this time. Any transfer of horses must be approved by the MGCB Stewards prior to entry. Todd Pappas is deemed a disqualified person. Todd Pappas has the right to appeal this decision within 10 days of this ruling.

***Status as of 6/10/2024 - Subsequent Ruling - MGCB received written notification that Todd Pappas filed a Withdrawal of Appeal with the Michigan Office of Administrative Hearings and Rules for his appeal of the MGCB Ruling 7659. The hearing scheduled for June 12, 2024, has been cancelled, and dismissed without prejudice. The original imposed sanctions of a fine of \$10,000 and the suspension of 1/07/2024 through and including 1/05/2025 remain unaltered. The horse remains disqualified, and all purse money earned shall be returned and redistributed.***

Trainer Jason Skinner, having waived his right to a Judge's hearing and being the trainer of record for the filly IDEAL OUT in race 1 on 5/14/2024 at Harrington Raceway, is fined \$1,000. It has been found that IDEAL OUT had a positive test (Dantrolene) testing over the allowable level (see DHRC rule: 8.3.3.3.2). IDEAL OUT has been disqualified, all purse monies to be returned. All fines are due within 10 days of receipt of ruling.

### **POSITIVE TEST- POST RACE**

New Jersey Racing Commission ("NJRC") licensee Vincent Stallworth was the programmed trainer of the horse "Stews Watching" when it competed in the 8th race at Freehold Raceway on Saturday, December 2, 2023; Following its performance, the horse "Stews Watching" was selected to submit blood and urine samples for analysis; The blood sample collected from the horse "Stews Watching" on December 2, 2023 identified the presence of Ketorolac, which is classified by the ARCI as a class 3 drug with a class A penalty; The presence of Ketorolac in the horse "Stews Watching" on December 2, 2023 is in direct violation of N.J.A.C. 13:71-23.1; Mr. Stallworth, per N.J.A.C. 13:71-23.4(d), requested a split sample of the post-race blood sample collected on "Stews Watching" from the 8th race on December 2, 2023 be sent to the UIC Analytical Forensic Testing Laboratory. The lab at the UIC Analytical Forensic confirmed the presence of Ketorolac in the sample. As a result of the positive post-race blood analysis, Mr. Stallworth is in violation of N.J.A.C. 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13.71-23.4(d) as such, Mr. Stallworth is suspended for a period of one year (365 days), Friday, August 23, 2024 through Thursday, August 22, 2025 inclusive. During this suspension, Mr. Stallworth is denied access to all grounds that are under the jurisdiction of the NJRC for any and all purposes. Mr. Stallworth is also fined the sum of \$5,000 dollars. Payment of the fine associated with this ruling must be received by the NJRC on or before August 22, 2025. Consistent with N.J.A.C. 13:71-23.7, the horse "Stews Watching" is hereby disqualified from sharing in the purse from the 8th race on Saturday, December 2, 2023. The purse is hereby ordered to be redistributed amongst the official order of finish. In addition to the penalty issued, 6 Multiple Medication Violation points as recommended by the Association of Racing Commissioners shall be assigned as a result of this penalty class A violation.

***Status as of 6/13/2024 - Stay - The New Jersey Racing Commission is in receipt of a notice of appeal and request for a stay from trainer Vincent Stallworth in connection with the one year suspension, five-thousand dollar fine, disqualification of the horse "Stews Watching," loss of purse and 6 Multiple Medication Violation ("MMV") points issued by the Board of Judges at Freehold Raceway for the violation of N.J.A.C. 13:71-23.1, N.J.A.C. 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13:71-23.4(d) in connection with a positive post-race analysis for Ketorolac in the horse "Stews Watching" in the 8th race on December 2, 2023. The Assistant Director, having considered the request for a stay, hereby grants a stay of the penalties pending a final determination by the Racing Commission. This matter will be transmitted to the Office of Administrative Law for a de novo hearing. Related ruling: 24FRE29, dated May 18, 2024***

**EXCESSIVE OR INDISCRIMINATE USE OF WHIP**

While driving #7 J S PEYTON in the 5th race at the Freehold Raceway on Saturday, January 7, 2023, Mr. Stillwell did strike #7 J S PEYTON with his driving whip leaving marks on the rear of the horse. The Board of Judges has determined that Mr. Stillwell's actions are in direct violation of N.J.A.C. Rule 13:71-2015(a),(b)1,(e) Driver Jacob Stillwell is hereby issued a driving suspension for a period of ten (10) days and is also fined the sum of one thousand (\$1000.00) dollars. Said suspension shall be served on ten (10) consecutive New Jersey Racing Days and shall be served on March 10, 2023, March 11, 2023, March 17, 2023, March 18, 2023, March 24, 2023, March 25, 2023, March 31, 2023, April 1, 2023, April 7, 2023 and April 8, 2023. This is Mr. Stillwell's 2nd violation of N.J.A.C. 13:71-20.15. The fine associated with this ruling must be received by the New Jersey Racing Commission on or before April 8, 2023.

***Status as of 6/13/2024 - Subsequent Ruling - By Ruling No. 23FRE7, dated February 2, 2023, the Board of Judges suspended driver Jacob Stillwell for a period of ten days and also fined the sum of one-thousand dollars for violation of N.J.A.C. 13:71-2015(a), (b)1, (e) in connection with improper use of the whip on the horse "J S Peyton" in the 5th race at Freehold Raceway on January 7, 2023. Mr. Stillwell appealed the decision of the Board of Judges and requested a stay of the penalties. In Ruling No. 24TRH10, dated February 15, 2023, a stay was granted and the matter was transmitted to the Office of Administrative Law ("OAL") as a contested case. On April 23, 2024, Administrative Law Judge Susan E. Scarola issued an initial decision, which affirmed the ten day suspension and \$1,000 fine issued by the Board of Judges. At its May 22, 2024, the New Jersey Racing Commission determined to adopt the initial decision. Having adopted the initial decision, the penalties issued in Ruling No. 23FRE7 are reinstated. Mr. Stillwell is hereby issued a ten day driving suspension and fined \$1,000.00. Said suspension will be served on 10 consecutive New Jersey racing days and shall be served on August 23, August 24, August 30, August 31, September 6, September 7, September 12, September 13, September 14, and September 19, 2024. Payment of the \$1,000.00 fine is due on or before September 19, 2024. Related rulings: 23FRE7, dated February 2, 2023; 23TRH10, dated February 15, 2023.***
