CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

OSRC 3769-2-26-A(10). Mr. Beaver's conduct was against the best interest of horse racing when using poor judgement by using his foot to impel #5 Wild As You, who had fallen onto the track and was preventing other horses from coming onto the track, back up onto her feet during the post parade of race 2 on 7/23/24 at Scioto Downs. Mr. Beaver is fined \$1000 and given a 15 day full suspension (7/26/24-8/09/24), or the penalty will be reduced to just a \$1000 fine if not appealed. The fine is due within 10 days of this ruling. During his suspension, Mr. Beaver is denied the use and privileges of all the grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Beaver may only be transferred by the Judges at Scioto Downs or by the OSRC. Mr. Beaver has 48 hours to appeal this decision to the OSRC.

Status as of 7/24/2024 - Subsequent Ruling - Ruling#24008C AND NOW, this 2nd day of May 2024, upon consideration that on March 15, 2024, the undersigned hearing officer issued an Order scheduling a telephonic prehearing conference in the above captioned matter to occur on April 3, 2024, at 10:00 a.m., and wherein the parties were provided with the dial-in number and access code needed to participate, and noting that the Order was served on Appellant at his home and email address on file with the Commission by first class mail, that the Order was not returned to the docket clerk as undeliverable by the postal service, and noting that Appellant failed to appear telephonically for the prehearing conference scheduled for April 3, 2024, at 10:00 a.m., and that Appellant has failed to file, by close of business on April 18, 2024, a written explanation as to why good cause exist to not dismiss Appellant's appeal, IT IS HEREBY ORDERED AND DECREED that Appellant's appeal of Ruling No. 23106PD in the above captioned matter is DISMISSED pursuant to 7 Pa. POSITIVE TEST- POST RACE

An administrative hearing was conducted on 7/11/23 to accept evidence and testimony relating to the positive post-race analysis of the horse "Here Comes Red," which competed in the 9th race on Friday, 5/12/23 at Freehold Raceway. As a result of the hearing, the Board of Judges has determined that: NJRC licensee, Brandon Mongiello was the programmed trainer of the horse "Here Comes Red" when it competed in the 9th race at Freehold Raceway on 5/12/23; The horse finished 1st in the 9th race and was selected to submit blood and urine samples for analysis; The blood sample collected identified the presence of the prohibited substance Orphenadrine which is in direct violation of N.J.A.C. 13:71-23.1; As a trainer licensed by the NJRC, Mr. Mongiello; is the absolute insurer of and responsible for the condition of a horse within his care and custody; Mr. Mongiello is found to be in violation of N.J.A.C 13:71-23.6(a)(b)(c)(d). As a result, Mr. Mongiello is hereby issued a full suspension for a period of 15 days, 8/25/23 through and including 9/8/23 and fined the sum of \$500.00 which must be received by the NJRC on or before 9/8/23. During the period of suspension, Mr. Mongiello is denied access to all grounds under NJRC jurisdiction. Pursuant to N.J.A.C. 13:71-23.7, the purse monies earned by "Here Comes Red" on 5/12/23 are ordered to be held pending the timely filing of an appeal. Should an

appeal be filed, the purse monies earned by the horse "Here Comes Red" on May 12, 2023 shall be held pending a final decision by the NJRC. Should no appeal be filed in accordance with N.J.A.C. 13:71-3.4 the purse monies earned by "Here Comes Red" on 5/12/23 shall be redistributed in accordance with the official order of finish. In addition to the penalty issued herein, 2 Multiple Medication Violation (MMV) points by the Association of Racing Commissioners shall be assigned as a result of this violation. BY ORDER OF THE NEW JERSEY RACING COMMISSION BOARD OF JUDGES

Status as of 7/25/2024 - Subsequent Ruling - Brandon Mongiello withdrew his appeal in Brandon Mongiello v. New Jersey Racing Commission, OAL Docket No. 07483-2023S, which resulted in the OAL returning his case file to the New Jersey Racing Commission. At issue in the appeal was Ruling No. 23FRE62, dated August 1, 2023, in which the Board of Judges at Freehold Raceway imposed a 15 day suspension, \$500.00 fine, disqualification of the horse "Here Comes Red" and 2 MMV points for violation of N.J.A.C. 13:71-23.1, 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13:71-23.7 in connection with a post-race positive test result revealing the presence of Orphenadrine in the horse "Here Comes Red" following the 9th race on May 12, 2023 at Freehold Raceway. Mr. Mongiello appealed the decision of the Board of Judges and requested a stay of the penalties. By Ruling No. 23TRH30, dated August 8, 2023, a stay was granted and the matter was transmitted to the Office of Administrative Law as a contested case. Having withdrawn his appeal, the penalties issued in Ruling No. 23FRE62 by the Board of Judges at Freehold Raceway are reinstated. Mr. Mongiello is hereby issued a 15 day suspension, fined \$500.00 and 2 MMV points are imposed. Said suspension will be served from August 23, 2024 through and including September 6, 2024. Payment of the \$500.00 fine is due on or before September 6, 2024. The horse "Here Comes Red" is disqualified from sharing in the purse from the 9th race on May 12, 2023 at Freehold Raceway. The Horsemen's Bookkeeper is hereby ordered to redistribute the purse monies from the 9th race on May 12, 2023 at Freehold Raceway accordingly. This matter is hereby referred to the Board of Judges for a hearing to determine if further disciplinary action is warranted in the event Mr. Mongiello fails to show good cause to the Board of Judges as to why the withdrawal of his appeal should not be deemed frivolous in accordance with N.J.A.C. 13:71-3.6. REFUSAL TO COOPERATE WITH AUTHORITIES DURING AN INVESTIGATION

A notice of hearing was sent to trainer Gregory Peck to appear before the Board of Judges at the Meadowlands Racetrack for a scheduled hearing on April 6, 2023. Mr. Peck did fail to appear at this hearing and as a result the Board of Judges issued Ruling No. 23MDH39 imposing an indefinite suspension of his New Jersey Racing Commission (NJRC) license until such time that he does appear. At Mr. Peck's request, a hearing was scheduled for April 3, 2024. Mr. Peck did appear at this hearing and, as a result, the indefinite suspension

has been terminated. The purpose of the administrative hearing, which was conducted on April 3, 2024 was to receive evidence and testimony regarding an ongoing investigation involving Mr. Peck. Previously, Mr. Peck informed an investigator that he possessed documents that supported the verbal assertions made to the investigator. Mr. Peck did receive a letter from the investigative staff of the NJRC, which formally requested that he produce various documents to the NJRC, including the documents he stated he possessed. Mr. Peck did acknowledge his receipt of the above-mentioned letter. At the April 3, 2024 hearing, Mr. Peck failed to provide the documents, which he stated that he possessed, that are material to an ongoing investigation, or any of the other douments requested. Mr. Peck now informs the NJRC that the documents he said he possessed do not exist. Having considered the evidence and testimony presented at this hearing, the Board of Judges has determined that: Gregory Peck is hereby issued a full suspension of his NJRC license for a period of sixty (60) days and is also fined the sum of two-thousand (\$2,000.00) dollars. Said suspension shall begin on May 8, 2024 and run through July 6, 2024 inclusive. The payment of the fine associated with this ruling must be received by the New Jersey Racing Commission on or before July 6, 2024. During the time of suspension Mr. Peck is denied access to all grounds under the ju
