The horse must also test in compliance with the above stated rules each time raced during the required pre-race detention period and shall be ineligible to race until the horse tests in compliance with this rule. During the term of the suspension, Christopher Dubois is deemed a disqualified person and denied access to all grounds under the jurisdiction of the New York State Gaming Commission. Any horses owned or trained by Christopher Dubois shall be denied the privilege of participating during the term of suspension, unless transferred to another licensee approved by the Presiding Judge at Saratoga Harness. The post-race sample collected from #1 “SOMETHING REEL” from the 4th race at Saratoga Raceway on 07/26/2024 was found to contain “METHYLPREDNISOLONE” at a concentration of 274.1 picograms per milliliter + /- 15.7 picograms per milliliter. “SOMETHING REEL” shall submit a sample for testing and remain on the Judge’s list until a negative result is obtained and must re-qualify.

During the term of the suspension, Gary Levine is deemed a disqualified person and denied access to all grounds under the jurisdiction of the New York State Gaming Commission. Any horses owned or owned or trained by Gary Levine shall be denied the privilege of participating during the term of suspension. (1st offense in this category).

LOW OR EXCESS LEVEL OF AUTHORIZED MEDICATION

Gricelda Orantes was the programmed trainer of the horse "Reachin For Heaven" when it raced in the 2nd race at Freehold Raceway on Friday, February 16, 2024. Following the 2nd race, "Reachin For Heaven" was selected to submit blood and urine for analysis. A report from Industrial laboratories identified the presence of the drug Dexamethasone above the allowable threshold in the blood sample. Ms. Orantes, per N.J.A.C. 13:71-23.4(d), requested that a split sample of the post-race blood sample collected on "Reachin For Heaven" from the 2nd race on February 16, 2024, be sent to the UIC Analytical Forensic Testing Laboratory. The lab at UIC Analytical Forensic Testing confirmed the presence of Dexamethasone above the allowable limits in the blood sample. The Board of Judges considered the circumstances and determined there to be aggravating factors, in that the presence of the drug Dexamethasone above the allowable threshold in the blood of the horse "Reachin For Heaven" was the second occurrence in one year of a post-race violation for Trainer Gricelda Orantes. As a result, Ms. Orantes is issued a full suspension of her New Jersey Racing Commission license for a period of twenty (20) days and fined the sum of seven hundred fifty (\$750.00) dollars. Said suspension shall begin on Saturday, May 24, 2025, and run through Thursday, June 12, 2025, inclusive. During the period of suspension, Ms. Orantes is denied access to all grounds under jurisdiction of the New Jersey Racing Commission for any and all purposes. The fine associated with this ruling must be paid on or before June 12, 2025. Consistent with N.J.A.C. 13:71-23.7, the horse "Reachin For Heaven" is disqualified from sharing in all purse monies earned on February 16, 2024. The purse is hereby ordered to be redistributed amongst the official order of finish. POSITIVE TEST- POST RACE

OSRC 3769-18-01-A(1a,10,13,15,16), 3769-18-02, 3769-17-43. Blood sample #918970 was tested by the Ohio Department of Agriculture ATL and was found to contain Salicylic Acid, a Class 4 drug, at a concentration of 18.3 micrograms per milliliter of plasma which exceeds the Regulatory Threshold of 6.5 micrograms per milliliter of plasma adopted by the OSRC. Blood sample #918970 was provided by #5 Big Booty Rudy, who finished 1st in race 4 on 5/11/24 at Scioto Downs, and was trained by Mr. Smith. Mr. Smith requested a split sample which was confirmed at 14.4 micrograms per milliliter of plasma. Mr. Smith has waived his right to a hearing. #5 is disqualified and placed 10th, and the purse earnings (\$6000) are ordered to be returned to Scioto Downs and redistributed accordingly. This is Mr. Smith's first medication violation in the last 365 days. Mr. Smith is fined \$1000, or \$500 if not appealed. Both the fine and the purse must be paid within 10 days of this ruling. Mr. Smith has 48 hours to appeal this decision to the OSRC.

On 8/21/24 the MSHRC held a hearing on the matter of MSHRC-02-24 and found that Mr. Vickerson was in violation of not being truthful in statements made to a department representative and failed to report the death of his horse CRUSH ME. The Commission found this to be conduct detrimental to the best

interest of racing which is a violation of MSHRC rule Ch. 17 Sec. 4 (3). The commission voted to impose a penalty of a \$ 500.00 fine and a 10 day suspension.
