CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

Trainer Doug Berkeley is hereby fined the sum of five thousand dollars (\$5,000.00) for conduct detrimental to the sport. The Board of Judges at the Meadowlands Racetrack received a report from the investigative staff of the New Jersey Racing Commission (NJRC) alleging that trainer Doug Berkeley was stabled at Big Z Equine, LLC. Big Z is a NJRC licensed training center located in Montague, NJ. The Board of Judges issued two hearing notices to trainer Berkeley; he failed to appear in both instances. In NJRC Ruling 50TRH dated 6/23/1999, pursuant to a formal written settlement agreement between trainer Doug Berkeley and the NJRC, trainer Berkeley agreed, in part, to never apply for any form of racing license in the State of New Jersey, or engage in any activities requiring licensure by the NJRC. Additionally, Berkeley agreed to not participate in any racing activity in the State of New Jersey, or in any other jurisdiction from a location in the State of New Jersey. He also agreed to never appear at any premises subject to the jurisdiction of the NJRC, including but not limited to licensed farms where racehorses are situated. By stabling at Big Z and racing in other jurisdictions, trainer Berkeley violated the settlement agreement. The fine associated with this ruling must be received by the NJRC on or before November 9, 2024. POSITIVE TEST- POST RACE

Mass. 205 CMR 3.29,(2A)(C). On 10/11/2024 Industrial Labs reported to Mass Gaming/Racing Division, the Post Race test result of blood sample E55190 collected on 9/24/2024 from the horse JON I LOVE DAT in Race 1 at Plainridge Park and finished 1st. The report revealed the presence of Dexamethasone in the blood at 13.8 pg/mL. The threshold is 5 pg/mL. On the same date the Lab also reported the Post Race result of Blood Sample E551830 collected from the horse BETH WHEELER on 9/23/2024 in Race 4 at Plainridge Park and finished 4th. It revealed the presence of Dexamethasone confirmed in the blood at 10.8 pg/mL. Trainer Chuck Connor Jr. was notified of both findings on 10/14/2024 and has waived his right to both a split sample and hearing. As a result of the violations Mr. Connor is hereby fined the sum of \$1,000.00. The horse JON I LOVE DAT finished first and is disqualified. The purse monies won or \$20,000.00 are ordered forfeited and returned for redistribution. The horse BETH WHEELER finished 4th and is disqualified. The purse monies won or \$3,200.00 are hereby ordered forfeited and returned for redistribution. Both the fine in addition to purse monies forfeited are to be returned within 48 hours of this ruling.

FAILURE TO OBTAIN PROPER LICENSE

As a result of the administrative hearing conducted on September 12, 2024, in which the purpose was to accept evidence and testimony relating to an investigative report dated August 12, 2024, filed by New Jersey Racing Commission ("NJRC") investigative staff, the Board of Judges has determined that: New Jersey Racing Commission applicant Ann DePietro was present at Restive Acres, an off-track stabling facility that is licensed by and under the jurisdiction of the NJRC, without a current 2024 NJRC license. Having considered the evidence and testimony presented at this hearing, the Board of Judges has determined: Ms. DePietro is in violation of N.J.A.C. 13:71-7.1(a)4, N.J.A.C. 13:71-7.26, N.J.A.C. 13:71-26.7 and N.J.A.C. 13:71-1.19. As such, Ms. DePietro is suspended for a period of thirty (30) days, from Friday, November 1, 2024, through Saturday, November 30, 2024, inclusive. During the period of suspension, Ms. DePietro is denied access to all grounds under the jurisdiction of the NJRC for any and all purposes. Ms. DePietro is not

currently licensed by the NJRC. As a result, the suspension shall be served as a period of license ineligibility.

POSITIVE TEST- PRE RACE

Rules 4120.4(A), 4120.3(A)(6), 4120.3(C) On 20 August 2024 the New York Drug Testing and Research Program reported to the New York State Gaming Commission that sample CV3602120, obtained pre-race, from the horse MAKING SPARKS, 3rd place finisher in race 6 on 12 August 2024 at Monticello Raceway, contained the presence of Cobalt at a concentration of 913.15+/-20.8 ppb. The presence of Cobalt in sample CV3602120 was confirmed by analysis of the referee portion of the sample by the State of Ohio Analytical Toxicology Lab at a concentration of 868+/-13 ppb. On 11 October 2024 Trainer Robert Dill appeared before a representative of the New York State Gaming Commission. Robert Dill, as trainer of MAKING SPARKS on 12 August 2024, is in violation of New York State Gaming Commission rules 4120.4(A), 4120.3(A)(6), and 4120.3(C). Pursuant to stated violations Trainer Robert Dill is hereby issued a full suspension of their occupational license for a period of 10 years. During the term of this suspension, Robert Dill is denied access to all course and grounds under the jurisdiction of the New York State Gaming Commission. Further, MAKING SPARKS is declared disqualified from said race and all purse earnings shall be returned and redistributed to appropriate finishers and must re-test for Cobalt prior to being eligible to race. Any owner or trainer transfer for horses under Robert Dill's care must be approved by the Presiding Judge at Monticello Raceway.

The Board of Judges at the Meadowlands Racetrack conducted an administrative hearing in the judges` office on September 25, 2024. New Jersey Racing Commission (NJRC) licensee, Rob Harmon, was present at the hearing. The purpose of this hearing was to discuss a report submitted to the judges by the Investigative Staff of the NJRC. The report alleges that an unlicensed trainer was stabled at Big Z Equine, LLC. Big Z is a NJRC licensed training facility located in Montague, NJ. At the hearing Mr. Harmon confirmed that he is part owner and the registered farm manager of Big Z Equine. Mr. Harmon also confirmed that an unlicensed individual was stabled at the training center in 2023 and continued to be stabled there for a period of several months after Mr. Harmon had been informed by the NJRC investigator that the unlicensed trainer had to vacate the premises, as Big Z Equine could be in possible violation of various rules and regulations of the NJRC including but not limited to N.J.A.C. 13:71-7.26. As a result of the administrative hearing, NJRC licensee Rob Harmon is hereby fined the sum of one thousand dollars (\$1,000.00) for failing to ensure that only NJRC licensed individuals were stabled at his training center. Furthermore, any subsequent infractions by Mr. Harmon or Big Z Equine may result in a greater penalty. The fine associated with this ruling must be received by the NJRC on or before November 9, 2024.
