### **POSITIVE TEST- POST RACE**

Ms. Brandstatter was the trainer of record for her entry # 5 THE DOWNTOWN BUS that raced at First Tracks on 5/11/24 in race # 8. The Industrial Laboratories of Denver, Colorado has notified the Maine State Harness Racing Commission that an analysis of blood sample #E507451 taken from the horse, The Downtown Bus at First Tracks LLC on May 11, 2024, disclosed the presence of TCO2 at a level 41.7 mmol/L. The finding of a high level of TCO2 is evidence of a violation of Commission Rule Chapter 11; therefore, this finding constitutes a positive test for the horse, The Downtown Bus. Ms. Brandstatter has agreed to enter into a consent agreement with the Maine State Harness Racing Commission. Ms. Brandstatter has been fined \$ 500.00 and suspended from participation for (15) days 12/08/24 - 12/22/24, this is a full suspension. The purse of \$ 300.00 has been ordered returned for redistribution.

### **POSITIVE TEST- POST RACE**

Jenna Cornelison was the programmed trainer of the horse "Dependlebury A" when it raced in the 13th race at Freehold Raceway on Saturday, October 26, 2024. Following this race, "Dependlebury A" was selected to submit a post-race blood sample for analysis. A report from Industrial Laboratories identified the presence of Altrenogest. Ms. Cornelison has waived her right to a split sample and hearing before the Board of Judges. As a result, Ms. Cornelison is hereby fined the sum of five hundred (\$500.00) dollars. Consistent with N.J.A.C. 13:71-23.7, the horse "Dependlebury A" is hereby disqualified from sharing in the purse from the 13th race on Saturday, October 26, 2024. The purse money will be shared according to the official order of finish. The payment of the fine associated with this ruling must be received by the New Jersey Racing Commission on or before December 21, 2024.

Blood samples collected post-race from NEED UR OPINION were tested and found to contain Dexamethasone at a concentration of 138.2 +/- 12.8 pg/ml this is above the allowable limit. As the trainer, Mr. Eckley is responsible for the positive test. NEED UR OPINION finished second in this race but is now disqualified and placed seventh. Purse money earned (\$1,700) by NEED UR OPINION must be returned within ten days of this ruling. Mr. Eckley is fined \$1,500 (fines are due within ten days of ruling) and issued a full 15 day suspension beginning November 18, 2025 up to and including December 2, 2025. Aggravating factors were considered in the determination of this penalty. Following the race, "TRANSFER THE ERA" was required to submit blood for analysis. A report from Industrial Laboratories identified the presence of Flunixin above the allowable

limit. As a result, Mr. Fusco is hereby issued a full suspension of his New Jersey Racing Commission license for a period of fifteen (15) days and is fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on November 26, 2024 and run through December 10, 2024 inclusive. During the period of suspension, Mr. Fusco is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission. Mr. Fusco has waived his right to a hearing with the Board of Judges and has accepted the penalties associated with this ruling. Consistent with N.J.A.C. 13:71-23.7 the horse "TRANSFER THE ERA" is disqualified from sharing in all purse monies earned on September 7, 2024. The fine associated with this ruling must be received by the New Jersey Racing Commission on or before December 10, 2024. On 11/20/2024 at PRC, Industrial Labs reported to the Massachusetts State Gaming Commission/Racing Division the Post Race Blood Sample No.E551575 collected on 11/04/2024 at Plainridge Park from the horse ALEX HAVING FUN in Race 5. The horse finished 1st. The report revealed the presence of Methocarbamol confirmed in blood at 1.85 ng/mL. The measure uncertainty of the method is 0.15 ng/mL at the threshold of 1 ng/mL. Trainer Kimberly was notified of the finding on 11/21/2024 and subsequently waived her right to both a split sample in addition to a formal hearing. This was Mrs. Vafiades 2nd medication violation within a 365 day period. As a result of the violation trainer Kimberly Vafiades is hereby fined the sum of \$1,500.00. In addition she is served a full suspension for a period of 15 days the start of the 2025 Plainridge Park Race Meet beginning 04/14/2025 through and including 04/28/2025. The horse ALEX HAVING FUN finished 1st and is hereby disqualified. The purse monies won or \$10,250.00 is hereby ordered forfeited and returned for redistribution. The purse money forfeited or \$10,250.00 must be returned within 10 days of this ruling or no later than 12/07/2024. The \$1,500.00 is due within 48 hours of this ruling or no later than 11/29/2024.
