POSITIVE TEST- POST RACE

OSRC 3769-18-01-A(1a,4e,10,13,15,16), 3769-18-02, 3769-17-43. Blood sample #926312 was tested by the Ohio Department of Agriculture ATL and was found to contain Flunixin, a Class 4 drug, at a concentration of 43 nanograms per milliliter of plasma, which exceeds the Regulatory Threshold of 20 nanograms per milliliter of plasma adopted by the OSRC. Blood Sample #926312 was provided by #4 Surfinthecanyon, who finished 1st in race 7 on 12/19/24 at Dayton Raceway, and was trained by Mr. Bateson. Mr. Bateson waived his rights to a split sample, DNA, and a hearing. This is Mr. Bateson's first medication violation in the last 365 days. #4 is disqualified and placed 8th, and the purse earnings (\$7000) are to be returned to Dayton Raceway within 10 days of this ruling and to be redistributed accordingly. Mr. Bateson is fined \$1000, or \$500 if not appealed, which is due to the OSRC within 10 days of this ruling. Mr. Bateson has 48 hours to appeal this decision to the OSRC.

Maria Reid was the programmed trainer of the horse "ALMOST KAREN" when she raced in the second race at Freehold Raceway on December 6, 2024. Following the race, "ALMOST KAREN" was required to submit blood for analysis. A report from Industrial Laboratories identified the presence of Flunixin above the allowable limit. An administrative hearing was held on January 15, 2025 in the Judge's office at The Meadowlands Racetrack to accept evidence and testimony regarding this matter. As a result of this hearing, the Board of

Judges have determined that NJRC licensee Maria Reid was the programmed trainer of the horse "ALMOST KAREN" when she raced in the second race at Freehold Raceway on December 6, 2024 and the presence of Flunixin above the allowable limit is in direct violation of N.J.A.C. 13:71-23.8 (g). As a result, Ms. Reid is hereby issued a full suspension of her New Jersey Racing Commission license for a period of fifteen (15) days and is fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on February 14, 2025 and run through February 28, 2025 inclusive. During the period of suspension, Ms. Reid is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission. Consistent with N.J.A.C. 13:71-23.7 the horse "ALMOST KAREN" is disqualified from sharing in all purse monies earned on December 6, 2024. New Jersey Racing Commission ("NJRC") licensee Vincent Stallworth was the programmed trainer of the horse "Stews Watching" when it competed in the 8th race at Freehold Raceway on Saturday, December 2, 2023; Following its performance, the horse "Stews Watching" was selected to submit blood and urine samples for analysis; The blood sample collected from the horse "Stews Watching" on December 2, 2023 identified the

presence of Ketorolac, which is classified by the ARCI as a class 3 drug with a class A penalty; The presence of Ketorolac in the horse "Stews Watching" on December 2, 2023 is in direct violation of N.J.A.C. 13:71-23.1; Mr. Stallworth, per N.J.A.C. 13:71-23.4(d), requested a split sample of the post-race blood sample collected on "Stews Watching" from the 8th race on December 2, 2023 be sent to the UIC Analytical Forensic Testing Laboratory. The lab at the UIC Analytical Forensic confirmed the presence of Ketorolac in the sample. As a result of the positive post-race blood analysis, Mr. Stallworth is in violation of N.J.A.C. 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13.71-23.4(d) as such, Mr. Stallworth is suspended for a period of one year (365 days), Friday, August 23, 2024 through Thursday, August 22, 2025 inclusive. During this suspension, Mr. Stallworth is denied access to all grounds that are under the jurisdiction of the NJRC for any and all purposes. Mr. Stallworth is also fined the sum of \$5,000 dollars. Payment of the fine associated with this ruling must be received by the NJRC on or before August 22, 2025. Consistent with N.J.A.C. 13:71-23.7, the horse "Stews Watching" is hereby disqualified from sharing in the purse from the 8th race on Saturday, December 2, 2023. The purse is hereby ordered to be redistributed amongst the official order of finish. In addition to the penalty issued, 6 Multiple Medication Violation points as recommended by the Association of Racing Commissioners shall be assigned as a result of this penalty class A violation.

Status as of 1/29/2025 - Stay - By Ruling No. 24FRE29, dated May 18, 2024, the Board of Judges at Freehold Raceway found Vincent M. Stallworth in violation of N.J.A.C. 13:71-23.1, N.J.A.C. 13:71-23.6(a)(b)(c)(d) and N.J.A.C. 13:71-23.4(d) in connection with a positive post-race blood sample for the prohibited substance Ketorolac, classified by the ARCI as a class 3 drug with a class A penalty, collected from the horse "Stews Watching" following its performance in the 8th race on December 2, 2023. Pursuant to N.J.A.C. 13:71-23.4(d), Mr. Stallworth requested a split sample of the post-race blood sample by the lab at UIC Analytical Forensic Testing Laboratory which confirmed the presence of Ketorolac. The Board of Judges imposed a one year (365 days) suspension and a \$5,000 fine. Mr. Stallworth appealed the decision of the Board of Judges and requested a stay of the penalties. By Ruling No. 24TRH20, a stay was granted and the matter was transmitted to the Office of Administrative Law ("OAL") as a contested case. On December 10, 2024, Mr. Stallworth failed to appear at the OAL for the scheduled hearing (on Zoom). As a result, on December 17, 2024, the OAL returned his case file and indicated that if Mr. Stallworth still wanted to have a hearing he must explain in writing to the NJRC why he did not appear. On December 12, 2024, however, Mr. Stallworth had sent an email to the OAL which explained that he attempted to attend the scheduled hearing (on Zoom) without success and requested that the matter be rescheduled. An OAL administrator replied to his email on December 13, 2024 and stated due to his failure to appear, the file would be closed and returned to the NJRC. The Acting Executive Director, having considered Mr. Stallworth's email to the OAL, hereby orders that the matter be retransmitted to the OAL for a de novo hearing and grants a stay of the penalties pending a final determination by the Racing Commission.
