#### **POSITIVE TEST- POST RACE**

Anthony Alagna was the programmed trainer of the horse "REMEMBER THE ALAMO" when he raced in the first race at The Meadowlands Racetrack on January 11, 2025. Following the race, "REMEMBER THE ALAMO" was required to submit blood and urine for analysis. A report from Industrial Laboratories identified the presence of 5-Hydroxydantrolene. At Mr. Alagna's request, split sample testing was performed at an independent laboratory. These testing results did confirm the presence of 5-Hydroxydantrolene. This is in direct violation of the rules and regulations of the New Jersey Racing Commission. A hearing was held in the judge's office at The Meadowlands Racetrack on June 5, 2025. As a result, Mr. Alagna is hereby issued a full suspension of his New Jersey Racing Commission license for a period of fifteen (15) days and is fined the sum of five hundred (\$500.00) dollars. Said suspension shall begin on August 18, 2025 and run through September 1, 2025 inclusive. During the period of suspension, Mr. Alagna is denied access to all grounds that are under the jurisdiction of the New Jersey Racing Commission. Consistent with N.J.A.C. 13:71-23.7 the horse "REMEMBER THE ALAMO" is disqualified from sharing in all purse monies earned on January 11, 2025. The fine associated with this ruling must be received by the New Jersey Racing Commission on or before September 1, 2025. MMV Points incurred 1/2 point Violation of N.J.A.C. 13:71-23.1 (a) (b) 14 Violation of N.J.A.C. 13:71-23.6 (a) (b) (c) (d) Violation of N.J.A.C. 13:71-23.7 (a) (b) (c) (d) Violation of N.J.A.C. 13:71-23.8 (g) 1

***Status as of 8/13/2025 - Stay - The New Jersey Racing Commission ("Commission") is in receipt of a notice of appeal and request for a stay from Anthony Alagna. By Ruling No. 25MDH75, dated July 28, 2025, trainer Anthony Alagna was issued a fifteen day suspension, \$500.00 fine, disqualification of purse, and 1/2 Multiple Medication Violation ("MMV") point by the Board of Judges at Meadowlands Racetrack for violation of N.J.A.C. 13:71-23.1(a) (b) 14, N.J.A.C. 13:71-23.6(a) (b) (c) (d), N.J.A.C. 13:71-23.7(a) (b) (c) (d) and N.J.A.C. 13:71-23.8(g) 1 in connection with a positive test result in the horse "Remember The Alamo" when it competed in the 1st race at Meadowlands Racetrack on January 11, 2025. The Acting Executive Director, having considered the request for a stay, hereby grants a stay of the penalties pending a final determination by the Racing Commission. Mr. Brandon Bates is a licensed Driver under KHRGC. Mr. Brandon Bates was involved in an incident at Oak Grove Incident File #IN20250006041 involving inappropriate conduct on Oak Grove Property. 810 KAR 3:020 Section 15 – H states a licensee may have their license revoked if the “The licensee or applicant has been ejected, ruled off, or excluded from racing association grounds in the Commonwealth of Kentucky or a racetrack in any jurisdiction”. Due to being ejected by Oak Grove Mr. Brandon Bates license in the Commonwealth of Kentucky is hereby revoked and he will only be eligible to apply for a license in the Commonwealth of Kentucky once he has been removed from the “No Trespass List” at Oak Grove.

Mr. Leslie Burton was the listed trainer of #2 Treasure G who was in the 8th Race on the 2-Year-Old Card that was raced at the Marion County Fair in Lebanon KY. Post race testing of sample E621293 that was sent to Industrial Laboratories confirmed in the blood Pyrilamine which is considered a Class B Medication in the Commonwealth of Kentucky. Mr. Leslie Burton was made aware of his right to a split sample and did waive that right. Mr. Leslie Burton had a hearing with the Board of Judges on 7/27/2025 in their office at the Red Mile. After hearing testimony and explanations, the Board of Judges do make the following ruling. #2 Treasure G has been disqualified and is 1st placed 5th DQ and is ordered to return the purse of \$4,500 (Four Thousand Five Hundred Dollars). Mr. Burton has hereby been issued a fine of \$1,000 (One Thousand Dollars) and a suspension of 30 (Thirty) Days the will start on 8/7/2025 ? 9/5/2025 for his first offense of a Class B medication violating 810 KAR 8:030. During his suspension Mr. Burton is denied access to any association under the jurisdiction of the KHRG. All horses owned or trained by Mr. Burton are only allowed to transfer with the approval of the Board of Judges at the Red Mile. Mr. Burton has been made aware of his right to appeal which must be sent to the President & CEO of the KHRG in 10 days of this ruling.

Jeffrey Sorenson, as trainer of record for the horse MISTER MIAMI in the 3rd race on 7/19/2025 at Vernon Downs, is issued a 60 day full suspension of his occupational license, beginning 8/20/2025 through 10/18/2025, plus a \$1,000 fine. The pre-race blood sample collected from MISTER MIAMI on 7/19/2025 was found to have a TCO2 concentration of 39.8 +/- 0.7 millimoles per liter. The sample was marked as not receiving Furosemide. This is excess of levels established by the New York State Gaming Commission (NYSGC). In addition, 3rd place earnings of \$900 by MISTER MIAMI must be returned and redistributed. MISTER MIAMI shall submit to a 6 hour pre-race detention for a period of 6 months, 8/20/2025 through 2/19/2026, without regard as to whether the horse is transferred to a new owner or trainer. The horse must also test in compliance with the above stated rules each time raced during the required pre-race detention period and shall be ineligible to race

until the horse tests in compliance with this rule. During the terms of the suspension, Jeffery Sorenson is deemed a disqualified person and denied access to all grounds under the supervision of the NYSGC. Any horses owned or trained by Jeffrey Sorenson shall be denied the privilege of participating during the suspension unless transferred to another licensee approved by the Presiding Judge.
