CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

71 IAC 5-1-15 On April 15, 2025 licensee Brandon Bates had his license revoked by the Kentucky Horse Racing and Gaming Corporation due to an incident on Oak Grove property. Per Indiana Horse Racing Commission rule 71 IAC 5-1-15 "Reciprocity" which states "If a person is suspended, expelled, or ruled off, or if his or her license is revoked or his or her application for a license has been denied, or he or she is under any other current penalty pursuant to the rules of the racing authority of any other state or country or of the gaming commission, such person shall stand suspended, expelled, ruled off, or denied a license at all tracks and satellite facilities operating under the jurisdiction of the commission

until the ruling has been withdrawn by the originating authority." Mr. Bates is therefore not eligible to participate in racing in the state of Indiana until this matter is resolved.

Status as of 8/22/2025 - Subsequent Ruling - Having been restored to good standing and reissued a license by the Kentucky Horse Racing and Gaming Corporation, Brandon Bates is restored to good standing in the State of Indiana and eligible to participate as of August 22, 2025.

POSITIVE TEST- POST RACE

Mass 205 CMR 3.29. On 07/23/2025 at PRC, Industrial Labs reported to the Massachusetts State Gaming Commission/Racing Division the POST RACE BLOOD SAMPLE, No.E544837. The sample was collected on 07/07/2025 at Plainridge Park Race Course from the horse DC ANNA in Race 10. The report revealed the presence of Dexamethasone in the blood at 10.5 pg/mL. The threshold is 5 pg/mL. Trainer Melissa Beckwith was notified of the finding and requested a split sample. The split sample was sent to Kenneth Maddy Analytical Chemistry Laboratory located in Davis, California. The result was reported on 08/22/2025 and confirmed the presence of dexamethasone. Ms Beckwith was notified of the Lab Report and waived her right to a formal hearing. As a result of the violation Ms. Beckwith is hereby fined the sum of \$1,000.00. In addition the horse DC ANNA finished 1st and is disqualified. The purse monies won or \$7,500.00 is forfeited and ordered returned for redistribution. The purse money is payable within 10 days of this ruling and the fine is payable within 48 hours of imposition.

POSITIVE TEST- POST RACE

Jody Weidman, trainer of MR FRENCH in the 9th race at Vernon Downs on 7/25/2025, having appeared before a representative of the New York State Gaming Commission (NYSGC) and waiving the right to a formal hearing and appeal, and waiving the right to a referee sample test, is issued a 15 day suspension reduced to 7 (9/7/2025-9/13/2025) and a \$1,000 fine reduced to \$500. The post-race blood sample from MR FRENCH was found to contain ALTRENOGEST, a prohibited substance, at a concentration of 82.8 +/- 1.6 picograms per milliliter. In addition, 2nd place earnings of \$1,125 won by MR FRENCH must be returned and redistributed. All horses owned or trained by Jody Weidman are denied access to the grounds of any facility under the supervision of the NYSGC, and none may be transferred during his 7 day suspension.
