Mass 205 CMR 3.29, ARCI. Trainer K William Krikorian was trainer of record on the horse GRAFFENBERG who raced at Plainridge Park on 7/15/2025 in Race 6. Post race analysis of blood sample E544985 taken from the horse GRAFFENBERG identified the presence of two NSAIDS. Flunixin was confirmed at 3.72 ng/mL at a threshold of 3 ng/mL and Phenylbutazone confirmed at 0.613 pg/mL at a threshold of 0.3 pg/mL. This is in violation of ARCI Anti Stacking Threshold. After being notified of the findings Mr. Krikorian requested a split sample. U C Davis of California conducted the analysis and on 09/10/2025 confirmed both findings. As a result Mr. Krikorian is hereby issued a full suspension for 15 days, beginning 09/12/2025 thru and including 09/26/2025. In addition he is fined the sum of \$500.00. The horse GRAFFENBERG finished 1st and is disqualified. The purse monies won or \$7,000.00 is forfeited and ordered returned for redistribution. The fine is payable within 48 hours of ruling and the purse money is due no later than 09/25/2025.

71 IAC 5-3-2(a)(1),(2); 8-1-1.5; 8-1-2; 8-1-4.2(10); Sample No. E642208 taken from the horse SKYWAYAWESTRUCK following the conclusion of race 13 at Hoosier Park on August 14, 2025 tested positive for dexamethasone (Class 4C). Industrial Labs reported a level of 8.06 pg/mL +/- 0.47 pg/mL which exceeds the IHRC threshold level of 5 pg/mL. As trainer of record Mervin Schwartz is in violation of the IHRC trainer responsibility and medication rules. Mr. Schwartz waived his right to a split sample and hearing accepting the following penalties; for this violation Mr. Schwartz is fined \$1000.00 which is due within
