CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

On July 18, 2025, in the barn area at Tioga Downs, licensee Edgar Clarke poured a harmful topical substance over tape, then applied the tape over a light switch in a premeditated effort to discourage someone from turning on the lights, in reckless disregard for the safety of anyone entering the barn. Clarke's intention was to cause physical injury, pain, or discomfort to anyone who removed or touched the tape in order to turn on the lights and therefore touched the substance. Clarke's actions endangered the health and welfare of other individuals, and the substance caused pain and bodily harm to two individuals, including an infant child. Clarke was aware that adults and minors would frequent the barn. Edgar Clarke was interviewed by a Commission Investigator at Tioga Downs on August 10, 2025, and admitted to purposely applying the tape and harmful topical substance to the light switch to discourage another licensee from turning on the lights. Edgar Clarke's actions are considered assault and conduct detrimental to the best interest of racing, and Clarke's experience, character or general fitness in harness racing is therefore inconsistent with the public interest, convenience or necessity, or with the best interests of racing in New York State. Due to the severity of the violation, the Commission hereby revokes Clarke's occupational license(s) beginning October 25, 2025. Clarke is deemed a disqualified person and is hereby ruled off all grounds under the jurisdiction of the New York State Gaming Commission.

Status as of 10/17/2025 - Stay - Edgar Clarke has requested a formal hearing and a stay in this matter. The stay has been granted until the Commission's decision on the pending adjudication.

POSITIVE TEST- POST RACE

Mr. Cushing was the trainer of record for his horse WHEN URHOT URHOT that raced at Cumberland Fair on 9/23/25 in race #8. A blood sample taken from When Urhot Urhot after the 8th Race on September 23, 2025, disclosed an elevated level of Dexamethasone at 22.0 pg/mL of serum. Dexamethasone is a therapeutic medication. The maximum allowable urine and/or blood concentration of Dexamethasone for a horse on a day for which it is scheduled to race is 5 picograms per milliliter of plasma or serum. When Urhot Urhot finished first in the 8th Race at the Cumberland Fair, in Cumberland, Maine on September 23, 2025. Pursuant to 01-017 C.M.R. ch. 11, presence of Dexamethasone is considered a Class 4 drug corresponding to a Class C penalty pursuant to 01-017 C.M.R. Chapter 17. Mr. Cushing has entered into a consent agreement with the MSHRC. Therefore, He has been ordered to return the purse winning of \$1,800.00 and pay a fine in the amount of \$500.00 for this infraction.

During this suspension, he and all horses trained and/or owned by him are barred from the grounds under the jurisdiction of the Virginia Racing Commission. Additionally, MORTON J is disqualified, finishing first and placed last. Mr. Merriman waived his rights to a split sample, DNA, and a hearing. This is Mr. Merriman first medication violation in the last 365 days. He is hereby fined \$1000 and 15 day full suspension. Pace N Boots is disqualified and as a result of that disqualification all purse money must be returned for redistribution (\$2900.00). The threshold for this controlled therapeutic medication is 5 pg/mL. As a result, Robinson is fined \$500.00 and must return all purse monies. Additionally, CRUSH HANOVER is disqualified, finishing second and placed ninth. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of the ruling. Blood sample #933089 was provided by #3 Power Hill, who finished 1st in race 2 on 9/10/25 at the Old Washington Fair, and was trained by Mr. Sowers. Mr. Sowers waived his rights to a hearing, split sample and DNA. This is Mr. Sowers first medication violation in the last 365 days. #3 is disqualified and placed 6th and the purse earnings (\$2853) are to be returned to the Old Washington Fair to be redistributed accordingly. Mr. Sowers is fined \$1000 and given a 15 day full suspension, the penalty will be reduced to a \$1000 fine and a 7 day full suspension (10/25/25-10/31/25). The fine and purse must be returned within 10 days of this ruling. During his suspension, Mr. Sowers is denied the use and privileges of all the grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Sowers may not be transferred unless approved by the Judges in Ohio or the OSRC. Mr. Sowers has 48 hours to appeal this decision to the OSRC.

On October 6, 2025, Mr. Taylor's request for a stay regarding this matter was also denied. Per Indiana Horse Racing Commission rule 71 IAC 5-1-15 "Reciprocity" which states "If a person is suspended, expelled, or ruled off, or if his or her license is revoked or his or her application for a license has been denied, or he or she is under any other current penalty pursuant to the rules of the racing authority of any other state or country or of the gaming commission, such person shall stand suspended, expelled, ruled off, or denied a license at all tracks and satellite facilities operating under the jurisdiction of the commission until the ruling has been withdrawn by the originating authority." Mr. Taylor is therefore not eligible to participate in racing in the state of Indiana until this matter is fully resolved or a stay is issued by the state of Delaware.
