POSITIVE TEST- PRE RACE

Trainer Mark Gray was the trainer of record on horse HOT GIRL in the 1st race on October 11th, 2025 at Shenandoah Downs. Pre-race analysis of blood sample #E670810 taken from HOT GIRL identified a Total Carbon Dioxide (TCO2) concentration of 40.0 +/- 2.6 mmol/L. This exceeds the maximum TCO2 concentration allowed per Virginia Racing Commission guidelines. As a result, Mr. Gray is fined \$1,000.00. Mr. Gray is also issued a

15-day full suspension from October 27th, 2025 through November 10th, 2025. During this suspension, Mr. Gray and all horses trained and/or owned by him are barred from the grounds under the jurisdiction of the Virginia Racing Commission. Any transfers to another trainer during Mr. Gray's suspension must be approved by the Virginia Racing Commission judges. All fines are due within 10 days of the ruling, or the Virginia Racing Commission licensee will be suspended until payment is received. 11VAC10-180-90.C. 4 Multiple Medication Violation (MMV) points assessed.

Trainer Michael Hall was the trainer of record on horse COVENTRY HALL in the 12th race on December 18th, 2024, at Rosecroft Raceway. Post-race analysis of blood sample #E721121 taken from COVENTRY HALL identified the presence of ADB-Fubinaca. This was identified by the primary Maryland Racing Commission laboratory, Industrial Laboratories. At Hall's request, a split sample was sent to the University of California, Davis for confirmatory analysis, which confirmed the presence of ADB-Fubinaca in the blood. As a result, Hall is fined \$2,500.00 and must return all purse monies. Given credit for 76 days served (last training start at Bally's Dover on February 27th, 2025), Hall will be issued a 284-day full suspension from May 14th, 2025 through February 21st, 2026. During this suspension, he and all horses trained and/or owned by him are barred from the grounds under the jurisdiction of the Maryland Racing Commission. Additionally, COVENTRY HALL is disqualified, finishing first and placed ninth. Once Hall's suspension is completed, he must reapply and receive approval from the Maryland Racing Commission to obtain licensure. Aggravating and mitigating factors were considered in the determination of this ruling. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of the ruling. COMAR: 09.10.03.04.B. Six Multiple Medication Violation (MMV) points assessed.

Status as of 10/24/2025 - Subsequent Ruling - The Maryland Racing Commission and counsel of appellant, Michael Hall, have mutually agreed to a Consent Order. In this Consent Order, the Maryland Racing Commission finds Mr. Hall in violation of COMAR 09.10.03.04B., COMAR: 09.10.03.04C., and COMAR: 09.10.03.04E. However, pursuant to the entry of the Consent Order, Mr. Hall is not admitting fault or liability with respect to the aforementioned regulations. The terms of the Consent Order are as follows: 1. Mr. Hall shall be assessed a fine of \$2,500.00. 2. Mr. Hall shall be issued a 308-day full suspension from February 27th, 2025, through and including December 31st, 2025. During this suspension, Mr. Hall and all horses trained and/or owned by him are barred from the grounds under the jurisdiction of the Maryland Racing Commission. 3. COVENTRY HALL is disqualified in the 12th race on December 18th, 2024 at Rosecroft Raceway, finishing 1st and placed 9th; and there shall be a purse redistribution. Mr. Hall must return the purse monies within 72 hours

of the execution of the Consent Order. 4. Mr. Hall shall be assessed six (6) Multiple Medication Violation (MMV) points. The provisions of the Consent Order shall be executed on October 24th, 2025.

Industrial Laboratories reported that sample #E541646 provided by the horse VEL EUGENE trained by LARRY KING following its first place finish in the sixth (6th) race at the Harrison County Fair (Corydon) on 9/20/25 contained Dexamethasone in the blood at a level of 22.0 pg/ml which exceeds the level permitted in accordance with the standard used in Indiana County Fair Races as prescribed by the Indiana Horse Racing Commission Rules, 71 IAC 8-1-4.2. Larry King, trainer of VEL EUGENE was advised of this positive test and of his rights to split sample testing. Trainer King chose to waive his right to send a split sample. 205 CMR 3.29 (3) (a) 2. On 09/22/2023 Industrial Laboratories reported to the Massachusetts State Gaming Commission/Racing Division the post race result of blood sample E62275. The sample was collected from the horse VIVIENS DELIGHT on 08/17/2023 who competed in Race 11 at Plainridge Park and finished 1st. The adverse analytical finding revealed the presence of the drug Glycopyrrolate in blood at 8.74 pg/mL. The measure uncertainty of the method is 0.85 pg/mL at the threshold of 3 pg/ml. Glycopyrrolate is a Class 4C Drug. After being notified trainer of record Michelle Lefebvre waived her right to both a split sample and a hearing. As a result of the violation Michelle Lefebvre is hereby fined the sum of \$1,000.00. The horse VIVIENS DELIGHT finished 1st and is hereby disqualified and placed last. The purse money won or \$4,250.00 is ordered forfeited, returned and redistributed. Blood sample #932707 collected at Northfield Park on 9/2/25 from the horse Diosa De La Danza was tested by the Ohio Department of Agriculture ATL and was found to contain Trendione. Mr. McGinnis waived his rights to a split sample, DNA, and a hearing. This is Mr. McGinnis first medication violation in the last 365 days. He is hereby fined \$1000 and 15 day full suspension. On 10/06/2025 Industrial Labs reported to Massachusetts State Gaming Commission/Racing Division the Pre Race analysis of blood sample E658553 taken from the CRANBOURNE N. The report confirmed TCO2 in Blood at 39.9 mmol/L. The measure uncertainty of the method is 2.3 mmol/L at the threshold of 37 mmol/L. Mr. Medeiros was notified on 10/07/2025 and on 10/17/2025 waived his right to a quarantine and on 10/23/2025 a hearing was conducted. As a result Mr. Medeiros is hereby issued a full suspension for a period of 30 days beginning 10/29/2025 through and including 11/27/2025. He is also fined the sum of \$500.00. The horse CRANBOURNE N finished 4th and is disqualified. The purse monies won or \$1,800.00 is forfeited and ordered returned for redistribution. All horses owned and/or trained by Mr. Medeiros MAY NOT be transferred during his suspension unless approved by the Judges or MSGC. During his suspension Mr. Medeiros is barred from all grounds governed by the MGC. Mr. Medeiros has 10 days from imposition to appeal this decision. The \$500.00 fine is due by 10/28/2025 and is payable to the Commonwealth of Mass. The purse money of \$1,800.00 is due by 11/07/2025 and is payable to Plainridge Park.

Jeffrey Sorenson, as trainer of record for the horse MISTER MIAMI in the 3rd race on 7/19/2025 at Vernon Downs, is issued a 60 day full suspension of his occupational license, beginning 8/20/2025 through 10/18/2025, plus a \$1,000 fine. The pre-race blood sample collected from MISTER MIAMI on 7/19/2025 was found to have a TCO2 concentration of 39.8 +/- 0.7 millimoles per liter. The sample was marked as not receiving Furosemide. This is excess of levels established by the New York State Gaming Commission (NYSGC). In addition, 3rd place earnings of \$900 by MISTER MIAMI must be returned and redistributed. MISTER MIAMI shall submit to a 6 hour pre-race detention for a period of 6 months, 8/20/2025 through 2/19/2026, without regard as to whether the horse is transferred to a new owner or trainer. Any horses owned or trained by Jeffrey Sorenson shall be denied the privilege of participating during the suspension unless transferred to another licensee approved by the Presiding Judge.

DENIAL OF LICENSE

After careful consideration, and in accordance with the State of Delaware Administrative Code, Delaware Harness Racing Rules and Regulations, the Delaware Harness Racing Commission ("DHRC") hereby denies Mr. Howard A. Taylor's (DHRC #2578) application for a license. During the course of a thorough review of Mr. Taylor's eligibility for a license, DHRC staff learned that the United States Attorney's office, Southern District of New York, presented evidence in United States v. Navarro, 20 Cr. 160 (MKV) that on multiple occasions Mr. Taylor purchased banned substances from individuals who were convicted in Federal Court with manufacturing and selling performance enhancing drugs. This conduct constitutes a serious violation of DHRC rules which prohibit a licensee from associating, directly or indirectly, with persons whose conduct is detrimental to the best interests of harness racing and who have been convicted of offenses related to the manufacture, distribution, or sale of illegal performance enhancing drugs. 5.1.7 Licensees' Obligation to Protect Horses. Each person licensed by the Commission shall do all that is reasonable and within his power and scope of duty to guard against and prevent the administration of any drug, medication or other substance, including permissible medication in excess of the maximum allowable level, to any horse entered or to be entered in an official workout or race, as prohibited by these rules. The United States Attorney's office, Southern District of New York, described United States v. Navarro, 20 Cr. 160 (MKV), as "a case arising from an investigation of widespread schemes by racehorse trainers, veterinarians, PED distributors, and others to manufacture, distribute, and receive adulterated and misbranded PEDs and to secretly administer those PEDs to racehorses competing at all levels of professional horseracing. **Contact DHRC for full ruling text**

Status as of 10/23/2025 - Stay - By letter dated October 1, 2025 and received by the Delaware Harness Racing Commission ("Commission") together with his appeal on October 6, 2025, Mr. Taylor seeks a stay of the October 1, 2025 denial of his license application. In his letter, Mr. Taylor states that his original request for a stay was denied by Presiding Judge Robert Corey on October 6, 2025. Mr. Taylor now requests that the Commission grant his request for a stay. Pursuant to Commission Rule 10.2.9.6, I have reviewed the letter and the arguments presented therein. Under the circumstances, it is my determination that Mr. Taylor's application for a stay is

granted only insofar as the Judges' October 1, 2025 decision is deemed a formal license denial under Commission Rule 5.1.15. Notwithstanding the foregoing, this order shall neither serve to extend an otherwise expired license, nor to grant a temporary license. Accordingly, pursuant to Commission Rule 5.1.1.1, Mr. Taylor remains ineligible to participate in pari-mutuel racing in Delaware during the pendency of his appeal. This matter will be scheduled for hearing at the Commission's next regularly scheduled meeting. SO ORDERED this 23rd day of October, 2025.

Mr. Brinson did use the whip in an unconventional manner while allowing his arm to be raised above his head violating 810 KAR 5:070 Section 9 – 3 – B. This is Mr. Brinson's 1st such violation in the Commonwealth of Kentucky in 2025.
