Trainer Lorenzo De Simone was the trainer of record on horse SPY BOOTH in the 11th race on October 16th, 2025 at Rosecroft Raceway. Post-race analysis of blood sample #E722051 taken from SPY BOOTH identified the presence of Flunixin at a concentration of 9.28 pg/mL ± 0.53 pg/mL. The threshold for this controlled therapeutic medication is 5 pg/mL. As a result, Mr. De Simone shall be fined \$500.00 and must return all purse monies. Additionally, SPY BOOTH is disqualified, finishing 1st and placed 9th; and there shall be a purse redistribution. All purse monies must be returned within 72 hours of this issuance,

and all fines are due within 10 days of the ruling. COMAR: 09.10.03.04.B. 1/2 Multiple Medication Violation (MMV) point assessed.

DHRC Licensee Michael Hall is summarily suspended (Effective 3/3/2025) pending a Judge's hearing. Mr. Hall will remain suspended until such a hearing is conducted (see DHRC rule: 10.2.3.1).

Status as of 11/5/2025 - Subsequent Ruling - CONSENT AGREEMENT An appeal of Michael P. Hall ("Licensee") has been filed with the Delaware Harness Racing Commission ("DHRC") of a Judges' Ruling that Licensee violated DHRC rule 8.3.2.1 in a post-race positive for a Class 1 drug. Licensee and the Judges hereby enter into this Consent Agreement to be submitted to the DHRC for review and approval. IT IS UNDERSTOOD AND AGREED THAT: 1. Licensee is the trainer of record for gelding THE NIGHT'S WATCH and was the trainer of record on February 6, 2025; 2. THE NIGHT'S WATCH had a routine post-race positive for ADB-Fubinaca at Bally's on February 6, 2025; 3. ADB-Fubinaca is a Class 1 drug under DHRC 8.3.1.1 for which there is no acceptable limit. Under DHRC 8.3.2.1, the sanctions for Class 1 violations, in the absence of extraordinary circumstances, state minimum license revocation of eighteen months, minimum fine of \$5,000, forfeiture of all purse monies, and assessment for the cost of drug testing; 4. On March 5, 2025, Licensee elected for a split sample; 5. On April 1, 2025, the split sample was determined to contain ADB Fubinaca; 6. May 19, 2025, the Judges held a hearing in this matter and issued a ruling sanctioning Licensee with a \$5,000 fine and suspension of eighteen months beginning on May 19, 2025 and concluding on November 12, 2026. Judges' Ruling concluded that Licensee was responsible for return of all purse monies and cost of the failed test and that there would be purse redistribution; 7. On May 22, 2025, Licensee filed an appeal of the May 19, 2025 Judges' Ruling to the DHRC appealing the Ruling and asserting that he did not administer ADB Fubinaca; 8. Licensee violated DHRC rule 8.3 in the above conduct; 9. Licensee and the Judges agree to the following disciplinary action; a. Suspension for 12 months beginning on May 19, 2025; b. Fine of \$10,000; c. Return of purse monies; and d. If and only if fine and return of purse monies identified in subsection band care remitted within 10 days after the date of the DHRC's Final Order in this matter, the suspension in subsection a shall lift on February 1, 2026; 10. In mitigation, Licensee avers the following which the Judges neither admit nor denies: a. Licensee asserts that he did not administer ADB-Fubinaca, but enters into this Consent Agreement for purposes of settlement and avoiding a public hearing; 11. The parties to this agreement are Licensee and the Judges; 12. Licensee acknowledges that he is waiving his rights under DHRC Rule 10.2.9 to a hearing before the DHRC; 13. Licensee acknowledges that he has

carefully read and understands this Consent Agreement, and is entering into this Consent Agreement freely, knowingly, voluntarily, and after having received or having been afforded the opportunity to receive the advice of counsel; 14. Licensee acknowledges that this Consent Agreement is a public record within the meaning of 29 Del. C § 10002 and will be available for public inspection and copying as provided for by 29 Del. C. § 10003; 15. The parties acknowledge and agree that this Consent Agreement is subject to approval by the DHRC; 16. If the DHRC accepts the Consent Agreement and enters it as an Order, the Consent Agreement shall be admissible as evidence at any future proceedings before the DHRC; 17. The parties acknowledge and agree that this Consent Agreement, along with any exhibits, addendums, or amendments hereto, encompasses the entire agreement of the parties and supersedes all previous understandings and agreements between the parties, whether oral or written. There are no other terms, obligations, covenants, representations, statements or conditions, or otherwise, of any kind whatsoever concerning this Agreement; 18. This Consent Agreement shall be effective upon acceptance by the DHRC and entry of the DHRC's Order.

On October 24, 2025, the New York Drug Testing and Research Program reported to the New York State Gaming Commission that blood sample #CV3621417, submitted by the horse GILLYS DE VIE, post-race (qualifier) on October 1, 2025, contained the presence of Altrenogest. Pursuant to the New York State Gaming Rules 4102.3(A), 4120.2, and 4120.4(A), trainer Jake Huff is hereby fined the sum of \$1,000.00. Further the horse GILLYS DE VIE, is required to provide a negative sample for Altrenogest and re-qualify prior to being eligible to race. Mr. McGinnis waived his rights to a split sample, DNA, and a hearing. This is Mr. McGinnis first medication violation in the last 365 days. He is hereby fined \$1000 and 15 day full suspension. Diosa De La Danza is disqualified and as a result of that disqualification all purse money must be returned for redistribution (\$4500.00) if this ruling is not appealed the penalty will be reduced to a \$500 fine and return of purse (with 15 day full suspension stayed pending no positives in the next 365 days). Blood sample #930548 collected at Northfield Park on 9/19/25 from the horse Alure was tested by the Ohio Department of Agriculture ATL and was found to contain over the allowable level of furosemide. At a concentration of 133 + -6 nanograms per milliliter of plasma. This concentration exceeds the regulatory threshold of 100 nanograms per Milliliter adopted by the O.S.R.C. Mr. McGinnis waived his rights to a split sample, DNA, and a hearing. He is hereby fined \$750. Alure is disqualified and as a result of that disqualification all purse money must be returned for redistribution (\$5300.00). If this ruling is not appealed the penalty will be reduced to a \$500 fine and return of purse. 3769-18-01(A)(10,13,15,16,)3769-18-02-17-43 The fine and purse must be paid by 11/11/25.

Blood samples drawn (post-race) were tested and found to contain Dexamethasone (a therapeutic drug) above the permitted level. A split sample was tested by Industrial Laboratories and that Dexamethasone level was confirmed. As the trainer, Mr. Parker is responsible for the positive test. BOMBAY TOM finished first and is now disqualified. Purse money earned (\$5,500) must be returned within ten days of this ruling. Mr. Parker is fined \$1,000 (fines are due within ten days of ruling). During the term of suspension, John Roach is ruled off all grounds under the jurisdiction of the NYSGC and deemed a disqualified person.

On October 21, 2025, in a public meeting the Commission voted on the hearing officers' report and recommendation. The Commissioners unanimously voted to deny Mr. Russell's Owner/Trainer application. Mr. Russell had 15 days to appeal this decision which he failed to do. Therefore, the application for an owner/trainer license is denied.
