USTA MEMBERSHIP ACTION

The USTA is indefinitely suspending the USTA membership of Mr. Gareth Dowse for violations of USTA Rule 26.16 (failure to submit information) and USTA Article § 1.04(a)(7) (failure to furnish information requested to supplement a membership application). Mr. Dowse failed to provide records and information requested by the Standardbred Racing Investigative Fund (SRIF) in collaboration with the USTA pursuant to an investigation into suspected violations of the USTA's Rules and Bylaws. As with the transfer of all ownership interests in a registered Standardbred horse, the USTA will scrutinize all attempted transfers of an interest in a Standardbred horse owned by Mr. Dowse to ensure that such transfer complies with the USTA's Rules and Bylaws and reserves the right to not recognize any such transfer. In addition, as Mr. Dowse is now indefinitely suspended, he is a "person not in good standing" under USTA Rule 4.130 and horses and USTA members associated with Mr. Dowse are subject to the applicable restrictions under USTA Rules Rule 20.15, 20.17, 22.05, 22.06, and 26.12. To ensure compliance with the USTA's Rules and Bylaws, the USTA advises its members to consult with officials at the USTA before participating in transactions or engaging in business activities involving registered Standardbreds with Mr. Dowse.

POSITIVE TEST- POST RACE

Mr. Jim Brinson was the listed trainer of #3 Capt Karma who was in the 6th Race at The Red Mile on 9/16/2025. Post Race testing of sample #E622076 that was sent to Industrial Laboratories confirmed in the Urine the presence of Oxymorphone which is a violation of 810 KAR 8:020 Section 2 – B and did violate 810 KAR 4:100 Section 3 – 1 by the trainer being the absolute persons responsible in the condition of their horse. Mr. Brinson requested a split sample that was sent to EQIAS Labs, which confirmed on 11/24/2025 that Oxymorphone was present in sample #E622076. Mr. Brinson appeared before the Board of Judges for a formal hearing on 12/5/2025 and 12/9/2025. After hearing all the evidence and testimony and considering all mitigating factors and facts the Board of Judges make the following ruling. #3 Capt Karma is hereby disqualified and is 3rd placed 8th and the purse of \$6,000 (Six Thousand Dollars) is ordered to be returned to The Red Mile by certified funds within 10 Days of this ruling for redistribution. Furthermore, Mr. Brinson is hereby issued a \$5,000 (Five Thousand Dollar) Fine and a Full 15 Day Suspension from 3/22/2026 through 4/5/2026 and is not allowed on any ground under the Jurisdiction of the KHRG during this time and no horses may be transferred without prior approval of the Board of Judges at the KHRG.

A marijuana cigarette was found in the center consol of the truck. Mitagating circumstances were considered for this penalty. Mr. Burt has been fined \$250 which must be paid within 10 days of this ruling. Mr. Burt has ten days to appeal this decision to the PSHRC, Bureau of Standardbred Racing. Mr. Leslie Burton was the listed trainer of #2 Treasure G who was in the 8th Race on the 2-Year-Old Card that was raced at the Marion County Fair in Lebanon KY. Post race testing of sample E621293 that was sent to Industrial Laboratories confirmed in the blood Pyrilamine which is considered a Class B Medication in the Commonwealth of Kentucky. Mr. Leslie Burton was made aware of his right to a split sample and did waive that right. Mr. Leslie Burton had a hearing with the Board of Judges on 7/27/2025 in their office at the Red Mile. After hearing testimony and explanations, the Board of Judges do make the following ruling. #2 Treasure G has been disqualified and is 1st placed 5th DQ and is ordered to return the purse of \$4,500 (Four Thousand Five Hundred Dollars). Mr. Burton has hereby been issued a fine of \$1,000 (One Thousand Dollars) and a suspension of 30 (Thirty) Days the will start on 8/7/2025 ? 9/5/2025 for his first offense of a Class B medication violating 810 KAR 8:030. During his suspension Mr. Burton is denied access to any association under the jurisdiction of the KHRG. All horses owned or trained by Mr. Burton are only allowed to transfer with the approval of the Board of Judges at the Red Mile. Mr. Burton has been made aware of his right to appeal which must be sent to the President & CEO of the KHRG in 10 days of this ruling.

Status as of 12/9/2025 - Subsequent Ruling - Mr. Burtons Appeal was dismissed per the Hearing Officer for KHRG as Mr. Burton had relayed his desire to drop said appeal. Mr. Burton has paid all fines and purse redistribution.

Blood sample #932542 collected at Northfield Park on 8/11/25 from the horse Volstarita was tested by the Ohio Department of Agriculture ATL and was found to contain Trendione. Miss Lecourt requested a split sample and DNA which did confirm the presence of Trendione. Miss. Lecourt had a hearing with the judges at Northfield Park on 12/7/25. This is Miss Lecourt's first medication violation in the last 365 days. She is hereby fined \$1000 and 15 day full suspension. Volstarita is disqualified and as a result of that disqualification all purse money must be returned for redistribution (\$10,000). If this ruling is not appealed, the penalty will be reduced to a \$500 fine and return of purse. (With 15 day full suspension stayed pending no Class 1 or 2 positives in the next 365 days) Mitigating circumstances were considered in determining this penalty. O.S.R.C.-3769-18-01 A (1,10,13,15,16) 3769-18-02 3769-17-43. The fine and purse must be paid by 12/18/25. Miss Lecourt has 48 hours to appeal this ruling to the OSRC.

POSITIVE TEST- POST RACE

OSRC 3769-18-01-A(1,10,13,15,16), 3769-18-02, 3769-17-43. Blood sample #932959 was tested by the Ohio Department of Agriculture ATL and was found to contain Dexamethasone, a Class 4 drug, at a concentration of 489 picograms per milliliter of plasma, which exceeds the Regulatory threshold of 5 picograms per milliliter of plasma, adopted by the OSRC. Blood sample #932959 was provided by #9 Rush In, who finished 1st on 8/30/25 at Scioto Downs, and was trained by Mr. Moore. Mr. Moore requested split sample and DNA testing which were confirmed. This is Mr. Moore's 2nd medication violation in the last 365 days. #9 is disqualified and placed 10th and the purse earnings of \$6500 are to be returned to Scioto Downs within 10 days of this ruling to be redistributed accordingly. Mr. Moore is fined \$1000 and given a 30 day full suspension (12/16/25-01/15/25), the penalty will be reduced to a \$1000 fine and a 10 day full suspension (12/16/25-12/25/25) if not appealed. The fine is due within 10 days of this ruling. During his suspension, Mr. Moore is denied the use and privileges of all grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Moore MAY NOT be transferred except by permission of the Judges in Ohio or by the OSRC.

Blood sample #937107 was tested by the Ohio Department of Agriculture ATL and was found to contain Dexamethasone, a Class 4 drug, at a concentration of 989 picograms per milliliter of plasma, which exceeds the Regulatory threshold of 5 picograms per milliliter of plasma, adopted by the OSRC. Blood sample #937107 was provided by #3 Rush In, who finished 1st in race 11 on 9/13/25 at Scioto Downs. Mr. Moore requested split sample and DNA testing which were confirmed. Mitigating circumstances make this again Mr. Moore's 2nd medication violation in the last 365 days. #3 is disqualified and placed 10th, and the purse earnings of \$8000 are to be returned to Scioto Downs within 10 days of this ruling to be redistributed accordingly. Mr. Moore is fined \$1000 and given a 30 day full suspension (1/16/26-2/14/26). The penalty will be reduced to a \$1000 fine and a 10 day full suspension (12/26/25-1/4/26) if not appealed. The fine is due within 10 days of this ruling. During his suspension, Mr. Moore is denied the use and privileges of all grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Moore MAY NOT be transferred unless permitted by the Judges in Ohio or the OSRC.

Mr. Daniel Noble was subject to a human drug test on 10/20/2025 that was performed by a KHRG Investigator at Cumberland Run at Corbin. Mr. Noble did fail the screening (urine test) as the screening tested positive for amphetamines and marijuana violating 810 KAR 2:030 Section 3 – 1 – C which states a positive result for a prescribed medication for which the individual has a valid prescription, but the prescriptions for which indicates that taking the medication may impair vision, impair the ability to perform normal daily functions, or cause drowsiness, or the prescription for which advise using when operating a car or machinery. Mr. Noble was removed from his remaining drive for the day. After appearing for a formal hearing before the Board of Judges and hearing testimony and evidence from Mr. Noble and his Attorney and considering all the facts the Board of Judges make the following ruling. Seeing as this is Mr. Noble first offense in 3 years and considering mitigating factors, he is hereby issued a \$500.00 (Five Hundred Dollar) Fine for violating 810 KAR 2:030 Section 3 – 1 – C and must pass an approved KHRG Drug Screening prior to participating in the Commonwealth of Kentucky.

Before the last blood drawn could be done Mr. Presto's groom took the horse from the State Barn with out letting the State Vet know the horse was leaving. This is against the best interest of racing. Mr. Presto waived his right to a hearing and is hereby fined \$1000 and 7day full suspension. If this ruling is not appealed the penalty will be reduced to a \$1000 fine. LOW OR EXCESS LEVEL OF AUTHORIZED MEDICATION

71 IAC 5-3-2(a)(1),(2),(b); 8-1-1.5; 8-1-2(a); 8-1-4.2(3) Sample No. E665707 taken from the horse THE GAMBLER following the conclusion of race 4 on September 30, 2025 at Hoosier Park tested positive for betamethasone (Class 4C) at a level of 22.1 pg/mL +/- 1.2 pg mL as reported by Industrial Labs. These findings were confirmed by split sample testing performed by University of California-Davis. The threshold level set by the Indiana Horse Racing Commission is 10 pg/mL. As trainer of record Mr. Quevedo is in violation of the IHRC trainer responsibility and medication rules. Mr. Quevedo waived his right to a hearing. For this violation Mr. Quevedo is fined \$500.00 which is due within seven days of this ruling. THE GAMBLER finished second placed seventh. Purse of \$11,375 to be returned and redistributed as follows: • No. 5 BRAVO ALPHA finished third placed second • No. 3 SWAN IN ALL finished fourth placed third • No. 2 HAWT YOGA finished fifth placed fourth •

Trainer Basil Sapienza was the trainer of record on horse BLUFFS CRUSH in the 11th race on November 6th, 2025 at Rosecroft Raceway. Pre-race analysis of blood sample #E722061 taken from BLUFFS CRUSH identified a TCO2 concentration of 41.2 ± 2.7 mmol/L. This exceeds the maximum TCO2 concentration allowed per Maryland Racing Commission guidelines. As a result, Mr. Sapienza is fined \$1,000.00 and shall return all purse monies. Mr. Sapienza shall also be issued a 30-day full suspension from November 17th, 2025 through December 16th, 2025. During this suspension, he and all horses trained and/or owned by him are barred from the grounds under the jurisdiction of the Maryland Racing Commission. Additionally, BLUFFS CRUSH is disqualified, finishing fourth and shall be placed seventh. BLUFFS CRUSH shall also be placed on the steward's list from November 17th, 2025 through December 16th, 2025. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of the ruling. COMAR: 09.10.02 Addendum A-11. Four Multiple Medication Violation (MMV) points assessed.

Status as of 12/11/2025 - Subsequent Ruling - The Maryland Racing Commission has received notice that appellant, Basil Sapienza, has withdrawn his appeal of Rosecroft Raceway judges' ruling RCR25-025 on December 8th, 2025. As a result, Mr. Sapienza is fined \$1,000.00 and shall return all purse monies. Mr. Sapienza shall also be issued a 30-day full suspension from January 19th, 2026 through February 17th, 2026. During this suspension, he and all horses trained and/or owned by him are barred from the grounds under the jurisdiction of the Maryland Racing Commission. Additionally, BLUFFS CRUSH is disqualified, finishing fourth and shall be placed seventh. BLUFFS CRUSH shall also be placed on the stewards' list from January 19th, 2026 through February 17th, 2026. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of the ruling. COMAR: 09.10.02 Addendum A-11. Said suspension shall be served on ten (10) consecutive New Jersey race days and will be served on November 28, 2025, November 29, 2025, December 4, 2025, December 5, 2025, December 6, 2025, December 11, 2025, December 12, 2025, December 13, 2025, December 18, 2025, and December 19, 2025. PA Code Title 7-205.409(c) Frank Tsipouras did have an exaggerated whipping motion not restricted to elbow and wrist action only and did raise his arm above shoulder height in the stretch while driving #8 DRINKIN AGAIN in the 13th race on 11/30/25 at Harrah's Philadelphia Racetrack. Mr.Tsipouras has been given \$1000 fine and a six month driving suspension .The suspension will be served and the fine will be paid sometime after December 19, 2025.
