#### **INAPPROPRIATE USE OF THE WHIP**

OSRC 3769-17-17-B&I. While driving #3 IMA Chic Magnet at the start and during the stretch of race 3 on 2/3/26 at MVR, Mr. Conrad did whip the horse using other than wrist and elbow action and while out of contention. This is Mr. Conrad's first whipping offense in the last 365 days. Mr. Conrad is fined \$500, the penalty will be reduced to \$300 if not appealed, which is due within 10 days of this ruling. Mr. Conrad has 48 hours to appeal this decision to the OSRC.

#### **EXCESSIVE OR INDISCRIMINATE USE OF WHIP**

Brandon Cruse was the driver of #5 River Of Fear in the 11 race. Mr. Cruse did use the whip excessively while the horse was out of contention. Mr. Cruse was issued a \$200 fine, for violation of DHRC rule 7.6.13.14.2.7. He did sign the waiver of hearing. Per DHRC rule 10.2.7.6 all fines are to be paid within 10 days of this ruling.

(Driving only) <i>Status as of 1/30/2026 - Subsequent Ruling - Having withdrawn his request for a hearing in this matter, the penalty is amended as follows: Mr. McNeil is hereby fined \$250 and issued a 3-day driving suspension to be served February 8, 2026, through and including February 10, 2026. This is a driving suspension only. Further violations of this manner will result in greater penalties.</i>

<b>INAPPROPRIATE USE OF THE WHIP</b>		
OSRC 3769-17-17-B&L. While driving #9 Rockinpoppin during the stretch in race 10 on 2/2/26 at MVR, Mr. Smith did excessively use the whip with other than wrist and elbow action. This is Mr. Smith`s first whipping violation in the last 365 days. Mr. Smith is fined \$500, the penalty will be reduced to \$300 if not appealed, which is due within 10 days of this ruling. MR. Smith has 48 hours to appeal this decision to the OSRC.
